## Hindu Import Export and International Trade Policy of KAILASA

Executive Order 10006 of August 14, 2020

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

## Section 1. Purpose.

The services offered by the Government of KAILASA, it's various departments and citizens have catered to the needs of all, not just Hindus worldwide. As late as 1000 CE, the Uniting Nations of KAILASA contributed to more than 33% of the world GDP.

In several countries there is a significant demand for Hindu goods, Hindu services and Hindu products. In most countries, such trade represents a significant share of gross domestic product.

Every Hindu product designed and revealed by Paramashiva in the Agamas was created by Paramashiva for imparting enlightenment and elevating consciousness. These Hindu products employ use of most ethical and non-violent resources. As per Hindu economic principles all economic resources that do not reduce upon sharing (like educational services) are offered for free, all economic resources that involve human survival (like food security and medical & health care) function on the basis of barter, only for all other economic activities Paramashiva allows use of currency. These economic principles of Paramshiva ensure and protect that quality and accessibility of education and survival resources are not disabled by distorted market practices. All Hindu products of KAILASA stand by these Hindu economic principles, transgressing ordinary material trade and impart direct benefits of positive life affirmative Hindu principles to the people and organizations in the entire supply chain.

The Hindu goods and services that were once internationally most demanded. In the 1700 CE Hindu economy KAILASA produced about 25% of world industrial output, and also accounted for 25% of the world trade. Hindu goods and services have seen a massive devaluation over the last thousands of years. The last few decades have seen a rise of counterfeit and adulterated goods, which has further caused a massive

depreciation in total value of the Hindu market. These counterfeit and adulterated goods have note only impacted livelihood of millions of indegenous craftsman they have also caused a loss of Hindu cultural heritage, and Hindu cultural identity.

My administration and KAILASA is committed to revive these authentic Hindu industries. The GDP increase because of these policies of KAILASA would support and empower Hindu world wide, supporting livelihood of authentic craftsman and businessman.

My administration and KAILASA is committed to strengthening and promoting global import export of Hindu products, Hindu goods, Hindu services that support Hindu principles.

Sec. 2. Policy. I am issuing a national call to action to:

- (a) Department of Commerce in conjunction with the Hindu World Trade Center shall organize International Expo for Hindu Sacred and Fine Arts, showcasing one million Hindu products
- (b) The representative of the Department of Information Broadcasting in Hindu Import Export Working Group shall create an e-platform to facilitate international trade and e-commerce, listing all Hindu products and services – in accordance to the "everything Hindu – we have it or we will get it" policy as directed in Executive Order # 10007 dated 15 October 2018.
- (c) All seventeen nations of KAILASA all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches shall
  - (i) Identify and develop domestic infrastructure (land, manpower, forest resources etc.)
  - (ii) Increase domestic production and reduce reliance on external import for all survival needs, such as food grains and medicine.
  - (iii) Increase trade and barter amongst the seventeen nations of KAILASA.

(d) Department of Commerce shall

- (i) Limit Perishables and Grain based trade and commerce amongst KAILASA nations. All surplus production would be utilized for offering Annadaan (free organic food) services only, and not sold.
- (ii) All development, infrastructure based trade and commerce shall be promoted internationally by developing the Hindu World Trade Center as per the Executive Order 10006 of 14 August 2020.
- (iii) Develop and expand trade in Sacred Arts such as Rudraksha jewellery

- (iv) Develop inter KAILASA trade to achieve self sufficiency.
- (v) Device novel solutions to increase exposure of existing trade goods from all seventeen kingdoms to the international market of Hindu diaspora.

(e) Department of Environment and animals shall

- (i) Device novel solutions and product derivatives from indegenous and other cattle breeds
- (ii) Relocate animal husbandry infrastructure facilities in close vicinity to agricultural land.

(f) Department of Agriculture

- (i) Increase production of all survival food grains, perishable but nutritionally utmost important vegetables and of Ayurvedic medicinal herbs.
- (ii) Produce and develop best quality organic indegenous seeds.

**Sec. 3. Establishment of a KAILASA's Hindu Import Export Working Group.** The KAILASA's Hindu Import Export Working Group is hereby established to facilitate an "all-of-government" effort to create KAILASA's Hindu Import Export as per the policy. The Working Group will be co-chaired by the Secretary of Department of Treasury, or his designee, the Secretary of the Department of Ministry of Sovereign, or his designee and the Secretary of State or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Information Technology, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

**Sec. 4. Responsibilities of the KAILASA's Hindu Import Export Working Group.** Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to execute this order.

The KAILASA's Hindu Import Export Working Group shall submit to the Presidential Executive office a monthly, quarterly and annual report on all Federal accounts and daily and weekly reports on implementation of all policies mentioned herein.

**Sec. 5. General Provisions**. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
