

KAILASA's E-passport to enable immediate, widespread and easy access to all the knowledge for Enlightenment and services of Sanatana Hindu Dharma

Executive Order 10001 of July 05, 2020

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. My administration and Kailasa is committed to giving the knowledge of Enlightenment and services of Sanatana Hindu Dharma to the entire humanity. KAILASA's E-Passport service will provide this access to all the knowledge for Enlightenment and services of Sanatana Hindu Dharma to everyone.

For the last 26 years, the Federal Government of Kailasa has been offering to the world, the knowledge of Enlightenment and services of Sanatana Hindu Dharma, by dedicated funds and thousands of hours in human resources, reaching out with these services door to door to every person. The world's most populated city is the internet, where more than two billion people reside at any given time in this world. The KAILASA's E-nation resides in this global city and makes Hinduism decoded and available to everybody. The E-Passport of KAILASA will provide the enlightened civilization of Sanatana Hindu Dharma and its contributions to everybody in the world. Anybody who would want to avail these services would be able to access them through the E-Passport.

Sec. 2. Policy. It is the policy of the KAILASA to provide all knowledge and enlightenment sciences for free, especially in the light of the global pandemic. At this time, it is critical to provide the services of enlightenment and Sanatana Hindu Dharma to the entire humanity and it is critical to enable these services through digital means. I am therefore issuing a national call to action to:

- (a) Provide E-Passport as a free service accessible in the most user friendly way, to anyone who wants to avail service
 - (i) Integrate all services under one portal

- (ii) The Department of Telecommunications and Broadcasting shall immediately enable single-sign-on service

- (b) Increase the availability of e-services of KAILASA and their integration with E-Passport, providing via digital and online mediums to all people, all over the world completely free access to benefits of all the knowledge and services Sanatana Hindu Dharma, in the fields of living enlightenment, health, medicine, art, science, technology, and social, judicial, political, and legal systems, etc.

- (c) Using E-Passport service enable immediate access to a network of online services of Kailasa, such as (but not limited to) :
 - (i) KAILASA's Nithyananda Hindu University courses and programs, such as (but not limited to):
More than 10,000 courses on all subjects such as mental health and well-being, science of power manifestation, dispute resolution, holistic health care, sciences of yoga, etc.
 - (ii) KAILASA's Nithyanandeshwara Hindu Temple rituals and its associated religious services that cater to revival of 10,000+ Hindu Sampradayas (sects, religious and cultural traditions).
 - (iii) KAILASA's Nithyananda Hindu Library scriptures & books, on all subjects such as (but not limited to) :
 - (1) Hindu economic policies
 - (2) Hindu democratic policies
 - (3) Hindu judicial policies, etc,
by giving access to two million books on Hinduism in digital format.
 - (iv) KAILASA's Hindu lifestyle products
 - (v) KAILASA's Hindu Life solutions that are offered online.
 - (vi) KAILASA's Hindu leadership services.

- (d) All the de facto embassies of KAILASA from all around the world, which presently are more than 1500, shall enable easy access to all Hindu services that they offer, to E-Passport holders.

- (e) To provide all future services of KAILASA via digital and online means in compatibility and compliance with E-Passport services.

Sec. 3. Establishment of a Kailasa's E-Passport Working Group. The Kailasa's E-Passport Working Group is hereby established to facilitate an "all-of-government"

effort to avail E-Passport service to the entire humanity. The Working Group will be co-chaired by the Secretary of Department of Information Technology, or his designee, and the Secretary of Department of Global Communication, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

This Working Group shall be responsible to collect and compile reports from all Samrajyas(kingdoms), Sarvajnanapeethams (spiritual kingdoms) and de facto embassies of Kailasa with complete statistics of the number of Hindus who have declared themselves as E-passport holders for the respective region.

Sec. 4. Responsibilities of the Kailasa's E-Passport Working Group. Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to KAILASA's E-Passport services.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
