

## **Establishment of International Agency For Eradicating Hunger from World by Hindu Food Production, Food Supply Chain Management and Distribution Mechanism**

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

**Section 1. Purpose.** My administration and KAILASA is committed to creating a world which is free from hunger. We are committed to providing relief to all victims of calamities. For the last 26 years, the Federal Government of KAILASA has created, maintained and expanded several humanitarian services providing food security and enabling well being of all its citizens, Hindus and the entire humanity.

For this we are establishing the international agency called Red Om. Through Red Om, KAILASA shall continue working towards its unified goal of eradicating hunger from the world, providing care to victims of calamities and felicitating each and every individual to expand the impact of their divine consciousness and experience their higher identity by means of offering selfless humanitarian services through KAILASA's humanitarian agencies.

### **Sec. 2. Membership and Establishment of a KAILASA's Red Om Group.**

The KAILASA's Red Om working group is established to create "A hunger free world". The working group will be co-chaired by the secretary of Dept. of Human Services, and secretary of Department of Agriculture. The Working group shall be composed of representative from the Department of Ministry of Sovereign, the department of global communication, and the Department of Environment and Animals, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

**Sec. 3. Committee Decision-making.** The Committee shall endeavor to make any decision on an action or determination under the direction of Veda-Agama principle, specifically Kamika Agama, Purva Pada with integrity, which shall be deemed to exist

where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Hinduism and the Head of **Uniting States** of KAILASA.

**Sec. 4. Implementing Measures and policies.** The written law of KAILASA, the Veda-Agamas declare :

॥ अन्नम् बहु कुर्वीत ॥  
“Annam Bahu Kurveetha”

which means, “Let us produce food in large quantities”. Unlike producing enough such that the produce may be exchanged, the law and policy of KAILASA is to produce food in large quantities so that the food may be widely shared such that nobody ever goes hungry on the planet earth.

It is the policy of KAILASA, to live and demonstrate these principles of Veda Agamas, especially during times when the global supply chain mechanism has undergone a massive disruption. I am therefore issuing a national call to action to:

- (a) All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty four Sovereign orders of KAILASA empowered with 10 million peacekeepers shall
  - (i) Organize all manpower resources under the international agency structure of the ‘Red Om’.
  - (ii) Work with all Hindus and citizens of their nation, organizing under this banner reaching out to all citizens in providing social services.
- (b) All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms) and all their branches shall
  - (i) Immediately restart (if stopped), and expand all their Annadaan (organic vegetarian free food offering) services
  - (ii) Enacting on the emergency clauses of - No Hungry Human Act
    - (1) To increase domestic production giving priority to perishable food items.
    - (2) To increase allocation of human resources
    - (3) To facilitate novel food distribution mechanism such as food packets so that the - “Nobody seeking food shall be refused of food” - clause of “No Hungry Human Act” is upheld, even during the COVID-19 pandemic

(iii) To increase allocation of land for cultivation by executing the Presidential Executive Order 10017 - dated 2 April 2020 - "To utilize every possible inch of land throughout the kingdom of KAILASA for cultivation."

(c) KAILASA Food Bank takes responsibility to maintain high integrity to procure pure sattvik (rejuvenating) and organic food to feed large scale people to bring holistic health.

**Sec. 5. Responsibilities of the Red Om Working Group.** Within one week of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to free and healthy food and free care to victims of calamities. This Working Group shall be responsible to collect and compile reports from all Samrajyams (kingdoms), Sarvajnanapeethams (spiritual kingdoms) and de facto embassies of KAILASA with complete statistics of the number of humans that have been served food and protected from calamities.

**Sec. 6. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
