

UPreserving the knowledge of the shastra through the “Hinduism time-capsule” project

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and agamas, it is hereby ordered as follows:

Section 1. Purpose. The history of Hinduism is the most valuable treasure known to humanity. Hinduism is advanced in every field known to society, such as but not limited to science, poetry, medicine, law and justice, arts, business, literature, grammar, mathematics, philosophy and the ancient science of power manifestation, and ultimately the spiritual truths lived and practised by all our ancestors. Each one of our ancestors has showcased extreme resilience and continued to protect these scriptural truths during the countless invasions and attacks faced by Hindus, solely for the next generation of Hindus to live and practice these great truths. Despite their attempts, Hinduism has been subject to the most brutal religious persecutions ever known to humanity, with deliberate attempts of cultural genocides in the past 2000 years.

Over the last few centuries, much of the sacred knowledge, education system, lifestyle, and original body language of Sanatana Hindu Dharma got diluted, lost, and destroyed by the foreign invaders’ systematic attempts to rule over Vedic India. The alien invaders destroyed the marvellous cultural architecture, temples, and deities and plotted a massive cultural genocide against Vedic India. Although most of our scripture burned, there is still a significantly small percentage of what we once had, existing in various parts of the world.

Sec. 2. Policy. My Administration aims to bring out the voice of the Truth that vibrated in the Ganges-Sarasvati civilization in the Vedic times through the spiritual and humanitarian initiative. “Hinduism Time Capsule” is specifically designed for capturing Hindu administration, Hindu history, Hindu cosmology, Hindu astrology, Hindu physics, Hindu chemistry, Hindu biology, and even anti-Hindu literature Hinduismpedia. Even the biography of great kings and queens such as Chatrapati Shivaji’s Son, Raja Raja Chola, Rajendra Chola, Vyasa is a scripture in Hindu tradition. Hinduismpedia thrives on bringing authentic knowledge encyclopedia on Hinduism, which will scrutinize Shastra Pramana, Apta Pramana. Hinduismpedia is an effort to organize, publish, preserve, teach, and spread the Shastras.

Sec. 3. Membership and Establishment of a KAILASA's Hinduismpedia Working Group. The KAILASA's Hinduismpedia working group is established to organize, publish, preserve, teach, and spread the Shastras and the history of Hinduism through the "Hinduism Time Capsule" project. The working group co-chaired by the secretary of Dept. of Information Broadcasting, or his designee and the Department of Enlightened Civilization secretary. The working group members composed of a representative from the Department of Ministry of Sovereign, Department of Human Services, Department of Vedic Science and Technology and the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All Working group members shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

Sec. 4. Responsibilities of the Hinduismpedia Working Group. Within one week of this order's date, the Working Group shall develop and submit a report that outlines a service plan to the Supreme Pontiff. Coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with access to all information on topics related to Hinduism. The working group shall also collect, organize, and publicly release all information on the Hinduismpedia official website.

1. The Department of Enlightened Civilization shall;
 - (a) Immediately collect all available material on Hinduism physically in the form of the printed book, tapes, cassettes, or digital format as ebooks, audio files, and video files.
 - (b) Reach out to all practising Hindus and the entire humanity who are willing to donate any legally owned materials such as but not limited to scriptures, palm leaves, and ancient Hindu books.
2. The Department of Information Broadcasting, per the existing laws of copyright, shall organize and legally make the complete knowledge of Hinduism freely available and accessible for all Hindus and humanity to preserve and protect for the future well-being of society..

Sec. 4. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. The Director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposal.

- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
