

Establishment of international Agency for bringing ethical treatment to environment

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of **Uniting States** of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in vedas and agamas, it is hereby ordered as follows:

Section 1. Purpose. Establishment of international agency Green Om. The Green Om will work to enforce ethical treatment to animals and Environment across the globe and to promote the core belief of Sanatan Hindu Dharma that divine exists in all living beings, both human and non-human, and Vasudhaiva Kutumbakam, the whole world is one family.

With the earth and the environment, protect and strengthen my pranic energy, protect and strengthen the apana air going down and out, protect and strengthen my vyana air circulating in the body-system. Give the divine light to my eye, the divine voice to my ear. Protect and promote the waters. Refresh and promote the greenery. Protect the bipeds (humans and birds). Protect the four-footed (animals). Bring the showers of rain from heaven.

~YajurVeda 14.8

Animals and plants are equally embodied with the existence of the Divine and fully deserve mutual respect and human compassion. Despite differences in intelligence and ability amongst varying life forms, the existence of the soul in all forms binds all of existence and demands peaceful, respectful coexistence amongst humans, animals and other elements of nature.

Section 2. Membership. The KAILASA's Green Om Working group shall be co chaired by secretary of Department of Environment and Animal , or his designee and the

Department of Agriculture, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

Section 3. Committee Decision-making. The Committee shall endeavor to make any decision on an action or determination under the direction of Veda-Agama principle, specifically Kamika Agama, Purva Pada with integrity, which shall be deemed to exist where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Hinduism and the Head of **Uniting States** of Kailasa.

Section 4. Implementing Measures. The Heads of the executive departments and members set forth in section 2 of this order will work under the Instruction of Head of Uniting States of Kailasa Supreme Pontiff HDH. The Department heads and members are instructed to implement the following measures:

- A. Promoting complete vegetarian lifestyle as directed in executive order dated November 14, 2020.
- B. To enforce complete stop the intake of Non-vegetarian food by practicing Hindus as directed in executive order dated November 14, 2020.
- C. To envisage complete intake of non cruel food by practicing Hindus.
- D. The animal sacrifice for the prescribed rituals will not be consumed by any human beings. (2 sentences)
- E. Enforcing the directive measures instructed in Kamika Agama, purva Pada, patala 30 verse 17-19. (Put as Point A)
- F. To create a toxins free, pollutants free environment where honeycombs are formed naturally, where hen, duck should survive by drinking drainage water (directive from Kamika Agama Purva Pada)
- G. To create ecosystems where the doorframe of every house will carry mango flower, neem flower, rice paddy hung at the door frame of the houses, such that it facilitates sparrows and other birds to eat.
- H. All the 64 sovereign orders of KAILASA to work with house of representatives and de facto ambassadors of KAILASA to implement the above directives.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
