

Sanyas - The Lifestyle of Enlightenment

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and agamas, it is hereby ordered as follows:

Section 1. Purpose. Sannyas emboldens living the lifestyle of completion. Through sannyas, many aspects that are elucidated in Hinduism have persistently sailed through heavy persecution, propelled by hope for a brighter future. These courageous men and women endured many hardships to keep the foundation of Hinduism alive. These principles are standing as core pillars for the religion, which underwent brutal biased - unfair treatment. Despite unimaginable hardships, this first sannysis remained firm in their beliefs and unwavering in their commitment to their dreams. The knowledge of Sannayas holds the sacrifice of previous sannysis thriving to keep the tradition alive.

Sannyas lifestyle highlights consequential responsibility for the whole world, *Vasudeva Kutubaha* - translation- The world as a whole is family. The required threshold to reach the highest peak potential of a being: achieved in the life of sannyas. Attributable to the Sannyas tradition, the knowledge and education, great sciences of Hinduism, temple, and ritual sciences are kept alive through sannyas. The vision of the sannysis to spread awareness in accordance to preserve world

peace and prosperity. The fundamental need is spiritual wellness and social service to promulgate global peace, realizing enlightenment in life, and serve the world. Whether it is architecture, art, science, culture, or language, Sannyasis have contributed the best things to Vedic tradition.

The Federal Government of Kailasa is paving the pathway by providing a unique opportunity to gain valuable professional experience and build leadership skills through illuminating the lifestyle of Sannyas to all the Hindus and youth around the world.

Sec. 2. Policy. It is the Federal Government of Kailasa's policy to expand the vision of sannyas to inspire, educate and empower all the practising Hindus in the field of the Vedic truths and vow to protect Veda Maataa (divine mother of sacred knowledge), and spread Vedic Dharma to the world.

I am therefore issuing a global call to action for all Hindus to:

(a) All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty-four Sovereign orders of KAILASA empowered with 10 million peacekeepers shall:

a. Commence a global initiative for the introduction of authentic Hinduism to all Hindus to establish a harmonious, healthy lifestyle for contributing to the world peace

- b. The Federal government of Kailasa is committed to support sannyasis, equipping them with the tools and flexibility for need to serve the world.
 - c. Empower priests and preachers (acharyas) to spread the Vedic lifestyle through rituals, powerful talks, and techniques.
 - d. Educate and empower public personalities and spiritual leaders to live Sanatana Hindu Dharma and occupy the Hindu seats in global universities and academia
 - e. Enrich and Enreach Hindus in the field of Medicine to practice Sannyas.
 - f. The Federal Government of Kailasa shall dedicate the human resources to provide their time, talents, energy, and service to educate and spread the Sannyas life.
- (b) Work towards the unified goal of restoring the enlightened Vedic civilization and usher humanity to the higher conscious possibilities, as initially intended by the incarnations and Vedic Rishis.
- (c) Train 1 million Sannyasis as Shaastra Dhaaris, expertise in the science of completion and increase this knowledge to the numerous web of Hindus in the world.

(d) Access to the knowledge of the sannyasi lifestyle is made possible through digital platforms and other innovative technologies.

3. Establishment of a Kailasa's Sannyas Working Group. The Kailasa's Sannyas Working Group is hereby established to facilitate an "all-of-government" to work towards the paramount responsibility of introducing the sannyasi lifestyle to preserve and protect Hinduism as a whole for every Hindu from the continuous chain of persecution. Spreading the knowledge of Sannyas will infuse Peacekeepers in the world, directly contributing to global peace. The Working Group will be co-chaired by the Secretary of Department of Religion and Worship, his designee, and the Secretary of the Department of Human Services, or designee. The Working Group members shall be composed of representatives from the Department of Enlightened Civilization, the Information Broadcasting, Global Communications, Office of Management and Budget (OMB). Representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Sec. 4. Responsibilities of the Kailasa's Sannyas Working Group. Within 24 hours of this order's date, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all

relevant stakeholders and executive departments and agencies (agencies) knowledge on the uniqueness and benefit of Sanyas.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. The Director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
