

## **Paramashivoham, An International Conference for Spiritual Awakening and Superconsciousness - A Global Initiative towards Inner Peace and World Peace**

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and agamas, it is hereby ordered as follows:

**Section 1. Purpose.** My administration and Kailasa is committed to spiritually enrich, enreach and support all Hindus around the world during these challenging times of COVID-19 through Paramashivoham, an international conference for spiritual awakening and superconsciousness. The crux of this happening is to push humanity to the next level of consciousness, to the consciousness of Paramashiva, the Ultimate Superconsciousness as per Hinduism. The Federal Government of Kailasa aims to felicitate each and every individual to expand the divine consciousness and experience their higher identity by manifesting the state, space, powers and being of Paramashiva through the offering of selfless humanitarian services as a part of KAILASA's globe initiative toward Inner Peace and World Peace.

The Federal Government of Kailasa has dedicated thousands of hours in human resources to conduct sessions for spiritual knowledge and solutions for all the practising Hindus and is working with a single unified goal for all the beings to experience Paramashiva through this conference regardless of the location.

**Sec. 2. Policy.** It is the paramount responsibility of the Kailasa Nation to avail the Paramashivoham conference, to anyone and everyone without discriminating caste, creed and age. I am therefore issuing a global call to action for all Hindus to:

- a. All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty-four Sovereign orders of KAILASA empowered with 10 million peacekeepers shall
  - i. Providing an easy, seamless registration method through different social media platforms and exploring other digital platforms to reach out to all the Hindus.
  - ii. Laying out an independent walkthrough for interested Hindus who register with the introductory book, questionnaire and the schedule of the conference.

- iii. Developing educational measures to increase awareness on the need to attend Paramashivoham and how it makes the individual manifest the state, space, powers, being, superconsciousness and Kailasa of Paramashiva.
- b. Increase the availability of Kailasa's services, i.e: Paramashivoham online by the digitization of the whole service from registration to initiation.
- c. The Department of Information Broadcasting must keep pace with technological advancements, regularly integrating current best practices, to reach out to the unmatched population of Hindus around the world, to promote the benefits of the International conference: Paramashivoham.
- d. Outline an all inclusive module for the sessions with the aim of enabling the Hindus, experience the state and space of Paramashiva besides manifesting the powers of Paramashiva.
- e. The program is made available freely to all Hindus.

**Sec. 3. Establishment of a Kailasa's Paramashivoham Working Group.** The Kailasa's Paramashivoham Working Group is hereby established to facilitate an "all-of-government" effort to avail Paramashivoham to all Hindus. The Working Group will be co-chaired by the Secretary of Department of Education, or his designee, and the Secretary of Department of Human Services, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

**Sec. 4. Responsibilities of the Kailasa's Paramashivoham Working Group.** Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus a spiritual awakening to manifest the superconscious breakthrough in their life.

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
