Achieve Universal Health Coverage and Enlighten, Empower, Heal the World through Initiation into Nithya Spiritual Healing

Section. 1. Purpose. My administration and Kailasa is committed to create a disease-free and holistically healthy world, a reality, by empowering each Hindu to awaken the healing energy in them. Energy healing is a holistic, non-invasive therapy that treats the body-mind as an energetic continuum. Our ancestors have revealed through years of research and groundwork that any physical or mental disease is an indication that there is a blockage in the energy flow. Through initiation by an enlightened Master, the representative of Paramashiva, any practising Hindu can practice the science of healing as a Nithya Spiritual Healer and become an open channel for the healing spiritual vibrations of Paramashiva to flow through them.

Especially during these challenging times, when many people around the world are suffering from various curable and incurable diseases, our consolidated efforts have resulted in the healing of hundreds of thousands of people from diseases such as but not limited to terminal cancer, brain tumours, fibromyalgia, paralysis, migraine and insomnia. The Federal Government of Kailasa shall continue working towards its goal of bringing the science of Nithya Spiritual Healing to the world through initiated healers.

- **Sec. 2. Policy and implementation:** It is the policy of Kailasa, to empower and heal the world through Nithya Spiritual Healing. I mandate all members of the Sovereign Order of Kailasa and sincerely recommend all Hindus to be initiated into the science of Nithya Spiritual Healing to continue to contribute to a safer, healthier future and the betterment of humanity. I, therefore, am issuing a nation's call to action to:
 - (a) In coordination with the Department of Health, the Department of Education and the ShriKailasa Uniting Nations for Alternative and Holistic Sciences- all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA
 - (i) Enrich and empower all Hindus to be initiated into Nithya Spiritual Healing
 - (ii) Organise in person and digital sessions for all inspired Hindus to be initiated into Nithya Spiritual Healing
 - (b) To device novel means to increase manpower, time resources and infrastructure allotted for healing services through Nithya Spiritual Healing sessions to reach the unmatched constellation of Hindus around the world

- (c) The Department of Information and Broadcasting shall enrich and empower the 2 billion Hindus to get benefitted through the Nithya Spiritual Healing by promoting the uniqueness and efficiency of this healing system through multiple social media platforms.
- (d) In strict compliance with the all health care and survival needs are served without charge clause of Paramashiva economic policy laid down in the Veda Agamas, all services offer all services absolutely free of charge. The citizens and beneficiaries would be free to offer any amount in donation or none based on their free will.
- Sec. 3. Establishment of a KAILASA's Nithya Spiritual Healers Working Group. The KAILASA's Nithya Spiritual Healers Working Group is hereby established to create a "disease-free" world and for all Hindus to understand the need for Healers initiation program. The Working Group will be co-chaired by the Secretary of Department of Health, or his designee, the Secretary of the Department of Education or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Information Technology, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.
- Sec. 4. Responsibilities of the KAILASA's Nithya Spiritual Healers Working Group. Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to execute this order. The Nithya Spiritual Healers Working Group shall submit a consolidated report to the presidential executive office with information related to the number of new initiates and the number of people in the world who have been healed.
- **Sec. 5. General Provisions**. a. Nothing in this order shall be construed to impair or otherwise affect:
 - i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

c.	This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
