

Empowering Hindus to join the global meditation initiative to heal the world and achieve world peace

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa and The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in vedas and agamas, it is hereby ordered as follows:

Section 1. Purpose. My administration and Kailasa draw attention to the symptoms and warning signs of PTSD, while also vowing to help all living and practicing hindus who suffer from it obtain the support required to provide a superconscious breakthrough. The need for mental health services will only increase in the coming years. Each year, an estimated 8 million adults experience PTSD. We are committed to helping and supporting human beings mentally, emotionally and psychologically by offering various Hindu solutions such as unclutching meditation techniques as revealed by Paramashiva in the Vedagamas. Research on the effects of meditation on stress, crime, violence, political decision making and even war all indicate that the changes in local and global consciousness are real, measurable, and profound.

Sec. 2. Policy. In order to highlight the urgent need to pay attention to mental health, KAILASA highlights the urgent need to redress the current situation. The Sovereign Order of Kailasa has an obligation to build an integrated network of support system capable of providing effective mental health services for all Hindus by spreading the science of unclutching. As part of our ongoing efforts to improve the quality of life for people struggling with mental health disorder, we have launched a global humanitarian meditation initiative to raise global consciousness using the science of unclutching, thereby healing the world and ushering world peace.

I am therefore issuing a national call to action to

- (a) All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty four Sovereign orders of KAILASA empowered with 10 million peacekeepers shall
 - (i) Immediately expand the global humanitarian meditation initiative of

Kailasa to prepare oneself for the technique of unclutching such as but not limited to,

- 1) Organizing sessions to chant the Mahavakya- Om Nithyananda Paramashivoham which is the spiritual password to connect to Paramashiva
- 2) Organizing sessions to chant/listen to of 108 upanishads which reveals the cosmic thought currents as compiled by Shri Ramachandra
- 3) Organizing sessions to chant/listen to Bhagavad Gita as revealed by Lord Shri Krishna as the manual for Enlightenment
- 4) Organise daily unclutching meditation workshops

(b) The Department of Human Services shall

- (i) Offer regular digital and in person unclutching sessions;
- (ii) Empowering all Hindus across the globe to join this initiative;

(c) The Department of information broadcasting shall

- (i) Ensure the Social Media Ambassadors to share the benefits of the science of unclutching;

Sec. 3. Establishment of a Kailasa's Science of Unclutching Working Group.

The Kailasa's Science of **Unclutching** Working Group is hereby established to facilitate an "worldpeace" effort to avail the science of unclutching to all Hindus. The Working Group will be co-chaired by the Secretary of Department of Religion and Worship, or his designee, and the Secretary of Department of Human Services, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Education, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Sec. 4. Responsibilities of the Kailasa's Science of Unclutching Working Group. Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to the science of unclutching. This Working Group shall be responsible to collect and compile reports from all Samrajyams (kingdoms), Sarvajnanapeethams (spiritual kingdoms) and de facto embassies of KAILASA with complete statistics of the number of humans and the total number of hours the live darshan id relayed.

Sec. 5. General Provisions.

- a. Nothing in this order shall be construed to impair or otherwise affect:
 - i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
