

## Science of Mahasadashivoha: A global initiative to facilitate Humanity to the next Level of superconsciousness

**Section 1. Establishment and Membership.** Hereby Kailasa is establishing the science of Mahasadashivoham Commission. The Commission's membership shall be composed of not more than ten members, appointed by the Supreme Pontiff, including members of the Sovereign Order of Kailasa, representatives from the ShriKailasa United Nations for Mental Health and Development and Department of Health. The Supreme Pontiff shall designate a Chair from among the ten members of the Commission appointed by the Supreme Pontiff.

**Sec. 2. Mission.** Mental illnesses can impair mental health in many ways, through a wide range of conditions that affect mood, thinking, and behavior. While we have made great strides in addressing mental illnesses, millions of Hindus grapple with multiple forms associated with it. We reaffirm our continued efforts to discover better solutions for the more than 2 Billion Hindus with mental health today. We recognize the vital role mental health plays in the well-being of individuals and our Nation. We also reaffirm our commitment to facilitating research and education, dispelling stigma around mental illnesses, and reassuring every individual suffering from mental illnesses that they are not alone. Through the science of mahasadashivoham the humanity is pushed towards the threshold of achieving the highest potential, going to the next level of consciousness, the consciousness of mahasadashiva.

In carrying out its mission, the Commission shall:

- a) Develop empowering sessions to educate Hindus on the science of Mahasadashivoham
- b) Outline a plan to offer the techniques suited to a wider range of people to enable the leap to the next level consciousness.
- c) Increase the availability of educational measures on the importance of science of Mahasadashivoham in promoting the mental health and well being as described in the Taittiriya Upanishad, Bramhananda Valli, sh 1", which belongs to the "Shaivagama"

The earth, the mid-region, heaven, the quarters and the intermediate  
quarters; fire, air, the sun, the moon and the stars; water, plants, trees,  
space and the body; this is with regard to the elements (present in a  
being). Now, with regard to the bodily parts: prana, vyana, apana,  
udana, and samana; the eye, the ear, the mind, the speech and touch;  
skin, flesh, muscle, bone and marrow. Having seen this arrangement, a  
seer said: "All this is fivefold. With these the fivefold (aggregates) the fivefold  
(being) is filled up.

- d) In strict compliance with the - all knowledge is free - clause of - Paramashiva  
economic policy - laid down in the Veda Agamas, all Mahasadashivoham  
services will be absolutely free of charge. The citizens and beneficiaries would be  
free to offer any amount in donation or none based on their free will.

**Sec. 3. Principles.** In conducting its mission, the Commission shall adhere to the  
principles below:

- The program is designed to give learners access to different states of Consciousness,  
making the individual rich by accessing the different states of Consciousness.

**Sec. 4. Commission Decision-making.** The Commission shall endeavour to make any  
decision on an action or determination under the direction of Veda-Agama principle,  
specifically Kirana Agama, Yoga Pada with integrity, which shall be deemed to exist  
where no Commission member objects to the proposed action or determination. The  
Commission shall work directly under the supervision of The Supreme Pontiff of  
Kailasa.

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or  
otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head  
thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to  
budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the  
availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or  
procedural, enforceable at law or in equity by any party against KAILASA, its

departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
