By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. My administration and Kailasa is committed to ensure a healthy, and promote well-being for all ages. development. Currently, the world is facing a global health crisis unlike any other — COVID-19 is spreading human suffering, destabilizing the global economy and upending the lives of billions of people around the globe. Amidst this pandemic, My administration has had extraordinary progress in recognizing severe psychological distress and diagnosing and treating mental illness, and my Administration is committed to building on that success. To that end, we have taken monumental steps to improve the efficiency and quality of healthcare for all the Hindus through the science of Nithya Kriyas.

Sec. 2. Policy. It is the responsibility of The Federal Government of KAILASA to work towards the unified goal of bringing excellent healthcare to all the Hindus. It is the policy of Kailasa Nation to avail the Science of Nithya Kriyas

Nithya Kriya is a series of healing yogic process that works on awakening the inner potential energy in the body (kundalini energy) in addition to the health benefits that accrue from contraction and expansion of the muscles in the body through various movements.

Nithya Kriya is unique in that, knowledge and techniques are drawn from the most authentic sacred yogic scriptures from India with the aim of curing and providing preventive care for various physical and mental ailments.

Nithya Kriya involves a combination of various Hindu techniques but not limited to Muscle Movements, sounds or visualization. I am therefore issuing a global call to action for all Hindus to:

- a. Engage the resources of Federal Government of Kailasa to facilitate the Nithya Kriya Program to everyone who is in need, including :
 - i. Laying out an independent walk through for Hindus who are interested in The Nithya Kriya program.
 - ii. Work with all Hindus and citizens of their nation, organizing under the international wing reaching out to all citizens in providing Nithya Kriya sessions on easy, seamless platforms.

- iii. Facilitate Zoom calls in person to teach the Nithya Kriyas.
- b. Increase the availability of Kailasa's digital services, i.e. The Nithya Kriya program by digitalization of the whole service and exploring innovative digital technology solutions to reach out to all Hindus.
- c. The Sovereign Order of Kailasa to permit, encourage facilitate digital e services such as:
 - Digitized Nithya Kriya sessions
 - Other digitized programs like Paramashivoham Level-2.
- Sec. 3. Establishment of a Kailasa's Nithya Kriya Working Group. The Kailasa's Nithya Kriya Working Group is hereby established to facilitate an "all-of-government" effort to avail Nithya Kriya programs to all Hindus. The Working Group will be co-chaired by the Secretary of Department of Health, or his designee, and the Secretary of Department of Human Services, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.
- **Sec. 4. Responsibilities of the Kailasa's Nithya Kriya Working Group.** Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to Shiva Deeksha initiation.
- **Sec. 5. General Provisions**. a. Nothing in this order shall be construed to impair or otherwise affect:
 - i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its

departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
