

Providing solutions for all Hindus using the ancient Vedic methodology of Vedic Astrology

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. The Vedas are the most immense and complete system of knowledge known to man. Vedas are the knowledge of the truth, absolute truth, the self's truth, and the underlying mysteries of existence. The Vedagamas provide various time-tested, age-old authentic solutions for humanity's problems, such as but not limited to influences of cosmic energies on an individual's mind, body, and livelihood. Detailed assessments of the planet's effect on an individual's life. The sacred scripture is in the Jyotisha Shastra (Vedic Astrology). The principles governing Vedic astrology have remained unaltered for thousands of years. The system of Vedic Astrology is vast, intricate, and complex. The Federal Government of Kailasa understands that solutions from the Hindu scriptures such as Jyotisha are a gift of Paramashiva. Access to sacred knowledge is a fundamental right to every practicing Hindu for the flourishing of humanity. It is the responsibility of the Federal Government of KAILASA to spread the science of Vedic Astrology. Vedic Astrology holds its power and influence on human beings due to the ancient Vedic science behind it. In short, it can shine a light on a person's life to guide him to his highest potential.

Sec. 2. Policy. Kailasa's policy is to spread and educate the 2 billion Hindus worldwide on the science of Vedic Astrology. Vedic Astrology can apply to each human incarnation – to each human born on this planet to steer the soul into developing to its fullest potential. By observing the celestial bodies' movements through time and space, a Vedic astrologer can identify obstacles in a person's path to self-realization and indicate how one can elevate himself to the ultimate goal in life: liberating himself from the material plane. Vedic Astrology can help diagnose an individual's physical, mental, psychological health conditions. The Federal Government of Kailasa has done a great deal of humanitarian work. In its peace-keeping role, it has managed brutal conflicts, eased tensions, and helped solve crises through Vedic techniques such as Vedic Astrology.

I am therefore issuing a national call to action ;

- (a) The Department of Religion and Worship in coordination with ShriKailasa Uniting Nations for Mystical and Spiritual Sciences shall;
- (i) Provide astrological solutions to all interested Hindus.
 - (ii) Facilitate and provide training manuals to equip all inspired Hindus pursuing the Vedic Astrology field of study.
 - (iii) To facilitate daily digital Vedic astrology services online through multiple social media platforms.

Sec. 3. Establishment of a Kailasa's Vedic Astrology Working Group. The Working Group will be co-chaired by the Secretary of the Department of Religion and Worship, his designee, the Secretary of the Department of Human Services, or designee. The Working Groups shall be comprised of representatives from the following Departments, Ministry of Sovereign, Enlightened Civilization, Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All Working Group members shall be full-time or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Sec. 4. Responsibilities of the Kailasa's Vedic Astrology Working Group. Within 24 hours of this order's date, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with access to Vedic Astrology. The Vedic Astrology working group also shall propose a schedule and compile daily reports on the number of people attending and benefitting from the Vedic Astrology sessions.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. The Director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented in consistency with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
