

Empowering humanity by awakening the leadership consciousness within all Hindus

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Establishment and Membership. Hereby Kailasa is establishing the Pragatataantrika Commission. The Commission's membership shall be composed of not more than twelve members, appointed by the Supreme Pontiff, including members of the Sovereign Order of Kailasa, representatives from the ShriKailasa Uniting Nations for Mental Health and Development and Department of Health. The Supreme Pontiff shall designate a Chair from among the twelve members of the Commission appointed by the Supreme Pontiff.

Sec. 2 Mission. The Federal Government of Kailasa recognizes the vital role mental health plays in the well-being of individuals. We also reaffirm our commitment to facilitating research and education, dispelling stigma around mental illnesses and providing solutions as revealed by Paramashiva in the Vedagamas, "Pauskara Agama, chapter 2, 11:12"

That kundalini of Sambhu(Siva) is eternally pure. But it is of inert nature. As such, it does not exist in an identical relationship with Siva(as the Sivasakti is). It remains as the assumptive power of Siva (parigraha sakti, that is, taken hold of when needed, left out when not needed). But in Sivasakti, there exists identical relationship with the Ultimate Lord.

In carrying out its mission, the Commission shall:

- a) Develop empowering sessions to educate Hindus on the science of Pragatataantrika
- b) Outline a plan to offer meditation techniques suited to a wider range of people to enable them to integrate Hindu spirituality into their lifestyle.
- c) Organise spiritual counselling workshops to enrich and educate the 2 Billion Hindus around the world about the importance of Pragatataantrika collaboration with ShriKailasa United Nations for Consciousness Studies and Practise.
- d) The Department of Education shall develop a manual for all inspired acharyas (teachers) to equip them with the right tools required to conduct the Pragatataantrika program for a wide range of interested participants
- e) The Department of Information and Broadcasting shall enrich and empower the 2 billion Hindus and all of humanity to participate in the Pragatataantrika program by promoting the benefits of the program

Sec. 3. Principles. In conducting its mission, the Commission shall adhere to the principles below

- (a) The Commission shall provide the environment for learners to effectively express themselves and deliver extraordinary performance in all walks of life, and enhance instincts for clear decision making.
- (b) The Commission shall enable the awakening of leadership consciousness within all Hindus.

Sec. 4. Commission Decision-making. The Commission shall endeavour to make any decision on an action or determination under the direction of Veda-Agama - "Pauskara Agama principle with integrity, which shall be deemed to exist where no Commission member objects to the proposed action or determination. The Commission shall work directly under the supervision of The Supreme Pontiff of Kailasa.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
