

## **Reviving the Hindu Compliance System and Body for the Whole World**

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of **Uniting States** of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in vedas and agamas, it is hereby ordered as follows:

**Section 1. Purpose.** Establishment of Hindu Compliance System and Body. The Hindu Compliance System and Body will work to create, promote, spread and teach the standard procedures for all products and services that are in compliance with Veda-Agamic principles. Hinduism has detailed procedures, standards, methodologies for everything. Hinduism is a rich religion with vast choices, It educates and empowers, is a non-restrictive, enlightening and empowering set of Principles.

The Hindu Compliance Body will work towards recognising the needs of citizens of KAILASA, compiling the standards, and policies such as - economic policy, religious policy, spiritual policy or strategies or any products and services, as mentioned by Paramashiva in Veda-Agama.

The Hindu Compliance body will work towards bringing innovation and provide solutions to global challenges by bringing together the various standards, procedures, and guidelines revealed in Veda-Agamic Scriptures. Through this body KAILASA will bring together all the experts to compile the standards as per need of global hindu diaspora, in integrity with the Shastra.

**Section 2. Membership.** The KAILASA's Hindu Compliance system and body working group shall be co-chaired by Secretary of each of Departments of Kailasa Ministry of Sovereign, Department of State, Department of Treasury, Department of Commerce, Department of Housing, Department of Human Services, Department of Education, Department of Enlightened Civilizations, Department of Information Broadcasting, Department of Health, Department of Vedic Sciences and Technology, Department of Global Communication, Department of Religion and Worship and Department of Environments and Animal or the designee of above department, such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or

office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

**Section 3. Committee Decision-making.** The Working group shall endeavor to make any decision on an action or determination under the direction of Veda-Agama principle, with integrity, which shall be deemed to exist where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Hinduism and the Head of Uniting States of Kailasa.

**Section 4. Implementing Measures.** The Heads of the executive departments and members set forth in section 2 of this order will work under the Instruction of Head of Uniting States of Kailasa Supreme Pontiff HDH. All the Department heads and members are instructed to implement the following measures:

1. To Create a committee of experts to document and publish the standards as per the need and responsibility of the Departments
2. Setting up a library which will locate, acquire, collect, organise, preserve the scriptures relevant to Key responsibilities of the The department.
3. Setting up various committees such as translation group to document standards from various Sanskrit Scriptures and make it available in various languages
4. Setting up various groups to educate the citizens of Kailasa, various organizations such as but not limited to
  - a. Religious organizations such as temple, mutt, monasteries etc
  - b. Service organizations Such as Om group of organizations etc.
  - c. Business groups and organizations

5. Creating Certification bodies to audit and accredit various organizations to issue the Hindu Compliance certificate for various products and services.
6. Create various groups to bring awareness among the citizens of Kailasa to choose for Hindu Compliance products and Services.
7. Create various groups for discussion and assessment for various standards whether it is Veda-Agamic Compliant or Not
8. Constituting a technical group with members from each of the Sampradayas (sects) of Sanatana Hindu Dharma who will participate in appointing members in expert group as mentioned in Section 4.1

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
