

Executive order 20005 of July 17, 2020

## **Establishment of International Agency to Provide Yogic, Ayurvedic, Naturopathy and Siddha Solutions and Medical care to whole world**

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of **Uniting States** of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in vedas and agamas, it is hereby ordered as follows:

**Section 1. Purpose.** On February 01, 2020, I declared this Corona epidemic will be resolved using consciousness. The COVID-19, which originated in December 2019, is spreading fast with more than 500,000 confirmed cases and 23,000 deaths to date, affecting around 170 countries and territories around the world in just 3 months.

Being the only Hindu nation, it is KAILASA's Dharmic responsibility to offer our humble services – the time tested, age-old authentic solutions from the Vedagamas, the ancient Hindu scriptures, to the entire humanity.

For the last 26 years, the Federal Government of KAILASA through the department of health addressed the holistic health needs of all its citizens through Yogic, Ayurvedic, Naturopathy and Siddha Solutions and Medical care. KAILASA shall continue working towards this goal, more so especially during the present time of COVID-19 pandemic, when the world is desperately looking for solutions.

### **Sec. 2. Membership and Establishment of a KAILASA's Yellow Om Group.**

The KAILASA's Yellow Om working group is established to create an international agency for helping and providing all humans Yogic, Ayurvedic, Naturopathy and Siddha Solutions and Medical health care.

The working group will be co-chaired by the secretary of the Department of Health and Department Human Services, or their designees. The Working group shall be composed of representative from the Department of Ministry of Sovereign, the department of global communication, and the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group

shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

**Sec. 3. Committee Decision-making.** The Committee shall endeavor to make any decision on an action or determination under the direction of Veda-Agama principle, specifically Kamika Agama, Purva Pada with integrity, which shall be deemed to exist where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Hinduism and the Head of **Uniting States** of KAILASA.

**Sec. 4. Implementing Measures and policies.**

I am issuing a national call to action to:

- (a) In coordination with the Department of Education, all seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA
  - (i) Organize all manpower resources under the international agency structure of the 'Yellow Om'.
  - (ii) Work with all Hindus and citizens of their nation, organizing under this international wing reaching out to all citizens in providing Yogic, Ayurvedic, Naturopathy and Siddha Solutions and Medical care.
  - (iii) To conduct Online Yoga sessions for improving the immune system and detoxifying the toxins from Body and mind
  - (iv) Immediately expand the Yogic, Ayurvedic, Naturopathy and Siddha Solutions and Medical health care, such as but not limited to :
    - (1) Conducting various programs through which aushadha were energized which upon use heals and protects from CORONA
    - (2) Promotion of various detox mechanism such as in take of HARITAKI which are also known to increase immunity against COVID-19
    - (3) Promotion of various detox mechanisms such as daily intake of castor-oil, Neem juice, Durva (Bermuda) Grass juice, etc.
  - (v) To increase the allocation of human resources in managing the health care of the citizens
  - (vi) In strict compliance with the - all health care and survival needs are served without charge - clause of - Paramashiva economic policy - laid down in the Veda Agamas, all services offer all services absolutely free of

charge. The citizens and beneficiaries would be free to offer any amount in donation or none based on their free will.

- (vii) Appointing integrity incharge in each of the entities to ensure the daily conduct of Yogic practices as mentioned in above sections and subsections.

(b) The Department of Health

- (i) To publish all preventive and supporting Ayurvedic health care recipes, such as :
  - (1) Neem and Turmeric paste
  - (2) Pachai Pattani Vratam
  - (3) Nirahara Samyama
- (ii) To device novel means to increase manpower and time resources allotted for care of prenatal children and pregnant mothers by extending the en-Pregnancy services.
- (iii) To expand health care facilities of resident KAILASA campuses, by adding facilities such as Intensive Care Unit, etc.

(c) The Department of Yoga shall provide training in The most authentic Yoga - Nithyananda Yoga compiled from Agama to create a larger group of Acharyas to who will further help citizens to Kailasa to learn Yoga and live a holistic life.

(d) To all citizens

- (i) A 28-day spiritual regimen involving vratha (Hindu fasting), meditation, chanting of sacred sound of Mahavakya, hygienic living, and social distancing called Pacchai Pattini Vratam, which is practiced in India as a method of cleansing, introspection, prayer and meditation. 30 million citizens of KAILASA worldwide would participate in this event to heal the world from the effects of COVID-19.
- (ii) It is KAILASA's dharmic responsibility to find spiritual solutions for all the world's problems. This program of intense prayer and fasting for 28 days to heal the world of COVID-19, is part of KAILASA's larger initiative for world peace and health.

**Sec. 5. Responsibilities of the Yellow Om Working Group.** Within one week of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to Yogic, Ayurvedic, Naturopathy and Siddha Solutions and Medical health care services.

This Working Group shall be responsible to collect and compile reports from all Samrajyams (kingdoms), Sarvajnanapeethams (spiritual kingdoms) and de facto embassies of KAILASA with complete statistics of the number of humans that have been impacted these services and impact on these services using relevant medical parameters.

**Sec. 6. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
