eN-Genius : International Camp to Awaken the Highest Potential of Children

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. My administration and KAILASA is committed to provide the next generation with a true awakening to realise their highest potential. Research shows that children in their early years have the capacity to absorb all the information around them. A child's potential is strongly influenced by the environment they grow up in. The Federal Government of Kailasa aims to create the perfect environments for children through spiritual awakening camps such as eN-Genius which focuses on developing the genius in every child by stimulating their higher-order thinking skills, awakening positive self-esteem, fostering teamwork, and strengthening their internal locus of control.

When young children are introduced to an enriching environment conducive to learning early in life, they often have higher IQ (Cognitive Intelligence), EQ (Social-Emotional Intelligence) and SQ (Spiritual Intelligence) scores. If a similar kind of experience for the same period of time is provided when a child is 15 years old, the impact on the child will be significantly less. These early experiences are critical for the development of the child. The eN-Genius Camp is just designed to awaken and express the extraordinary dimensions in every child through all areas of growth while retaining the essence of the true Vedic Learning System through the enlightened based learning.

Sec. 2. Policy. It is the policy of my administration and KAILASA to Children from all backgrounds to awaken their true potential and to become successful and thriving leaders. All eN-Genius camps must include these core concepts

- 1. Whole Brain Learning
- 2. Right Brain Stimulation
- 3. Brain Yoga
- 4. Quantum Memory
- 5. Confidence High Self Esteem
- 6. Vedic Culture including stories of enlightened beings, theatre, pottery making, rangoli, sculpting etc.
- 7. Creative and Performing Arts

Sec. 3. Establishment of a Kailasa's eN-Genius Group. Kailasa's eN-Genius Group is hereby established to create an "environment to produce leaders for the next generation". The Working Group will be co-chaired by the Secretary of Department of Education, or his designee, and the executive director of ShriKailasa Uniting Nations for Children and Youth. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Religion and Worship, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Sec. 4. Responsibilities of the KAILASA's eN-Genius Group. Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to execute this order. The KAILASA's eN-Genius Group shall submit to the Presidential Executive office a daily and weekly report on the progress of each enrolled child.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
