

# **Sarvajnapeetha, Happening of the Glorious Vedic Renaissance and Rewriting the History of Human Civilization**

By the authority vested in me as the Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

**Section 1. Purpose.** My administration and Kailasa feel it is our paramount responsibility to pioneer the glorious Vedic renaissance and rewrite human civilization's history to revive Hinduism to its original glory. This greatest happening shall be possible through the revival of Sarvajnapeetha, the Seat of Enlightenment.

The Vedic civilization stands on three core foundations:

1. The seat of knowledge and philosophy that preserves the Vedic wisdom
2. Sacred Arts and Architecture
3. The seat of language – the perfect, most refined linguistic expression of the Truth

Whenever there comes danger to any of these core foundations, the All-knowing Spiritual Seat of Knowledge or Sarvajnapeetha, through its presiding Incarnation, the living representative of Paramashiva, descends as the Jagadguru to revive, protect and radiate Sanatana Dharma or Hinduism for the whole of human civilization, as revealed by, Bhagavan Krishna in Bhagavad Gita, chapter 4, 7-8 verse

yadā yadā hi dharmasya glānir bhavati bhārata |  
abhyutthānam adharmasya tadātmānaṁ sṛjāmy aham ||  
paritrāṇāya sādḥūnāṁ vināśāya ca duṣkṛtām |  
dharma-saṁsthāpanārthāya sambhavāmi yuge yuge ||

"Whenever and wherever there is a decline in spiritual practice, O Bharat, and a predominant rise of irreligion at that time I descend Myself. To enrich and deliver the pious beings, to annihilate the miscreants, and to re-establish the sacred principles of cosmic truth, I myself appear, age after age."

The Federal Government of Kailasa is working on the unified goal of the Kailasa's revival, the Hindu nation to revive and share all the best things revealed in Sanatana Hindu Dharma's Veda-Agamic scriptures, to contribute to the universe and humanity. Kailasa brings spiritual legitimacy, religious legitimacy, social legitimacy, cultural legitimacy,

historic legitimacy, economic legitimacy, and political legitimacy to Sanatana Hindu Dharma.

**Sec. 2. Policy.** It is the policy of The Federal Government of Kailasa to advance the knowledge of Sarvajnapetha by reaching out to the unmatched constellation of Hindus around the world. It shall be the executive branch's policy to improvise the infrastructure projects included in the Sarvajnapetha to create an authentic experience for all the Hindus, enhance the productivity of Hindu activities, improve quality of life, protect the Sanatana Hindu Dharma, and strengthen the core principles of Hinduism. The Federal Government of Kailasa is initiating the Vedic Renaissance, happening in all its originality, depth, and expanding to enrich and enrich all the practicing Hindus, reclaim the Vedic heritage and reconnect with their higher self. And any Hindu who resonates with this global vision and wishes to make a significant contribution becomes a channel for the Cosmos to shower wealth in their lives.

I am therefore issuing a national call to action to:

- (a) All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty-four Sovereign orders of KAILASA empowered with 10 million peacekeepers shall;
  - i. Outline and identify strategic plans for the revival of the Vedic sciences, such as but not limited to:
    1. Authentic education- Gurukul and Hindu Universities
    2. Yogic powers - Power Manifestation of 464 powers of Paramashiva
    3. Vedic Medicine
    4. Vedic technology
    5. Sacred arts
    6. Preserving texts - Revival of Hindu Libraries and ancient texts
    7. Sovereign Order of Kailasa
- (b) Organize an educational brief, in collaboration with ShriKailasa Uniting Nations for Ancient Sciences, on the need for immediate unified efforts for revival of Sarvajnapetha on all digital platforms to reach out to all the Hindus around the world.
- (c) Reaching out to Hindus to contribute land or infrastructure that shall be used to effectively build resilient infrastructure, which will be the foundation to foster the revival of sacred temple sciences.
- (d) Develop a systematic structure of introductory books and videos and one-on-one communication with tKailasa's peacekeepers for all Hindus who feel responsible to contribute to Sarvajnapetha.

**Sec. 3. Establishment of a Kailasa's Sarvajnapaetha Working Group.** The Kailasa's Sarvajnapaetha Working Group is hereby established to facilitate an "all-of-government" effort to increase the awareness of Sarvajnapaetha to all the Hindus. The Working Group members will monitor by the Department of Enlightened Civilization co-chaired by the Secretary of Department of Religion and Worship, or designee, Secretary of Department of Human Services, or his designee. Working Group members comprised of representatives from the following Departments: Ministry of Sovereign, Enlightened Civilization, Information Broadcasting, Global Communications, Office of Management and Budget (OMB), ShriKailasa Uniting Nations for Ancient Sciences, ShriKailasa Uniting Nations for Ancient Heritage. Representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All Working Group members shall be full-time or permanent part-time, officers or subjects of the Federal Government of Kailasa.

**Sec. 4. Responsibilities of the Kailasa's Sarvajnapaetha Working Group.** Within 24 hours of this order's date, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) the access to the knowledge of Sarvajnapaetha.

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. The Director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
