

# Redesigning the Future of Humanity through Sacred Science of Akashic Readings

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and agamas, it is hereby ordered as follows:

**Section 1. Purpose.** My administration and Kailasa are committed to guiding humanity to find answers directly from the cosmic archives to all questions that life possesses. Celestial archives are the mystical records of all the events, words, thoughts, and actions that have ever happened in the cosmos. The Federal Government of Kailasa aims to create a world that guides Hindus to find the goal of their lives through a robust Hindu methodology - Akashic Readings. Especially during the time of desperation and confusion, Mahakalabhairava, the manifestation of Paramashiva, guides every individual using the infinite cosmic library to benefit every seeking individual and the entire humanity by providing access to the Akashic Records. The Federal Government of Kailasa shall continue working towards delivering spiritual healing of physical and emotional conditions. Department of Mental Health will provide understanding behind every life's happening, dissolve karmic blockages from the past, and provide clarity and blessing to redesign the future for the entire humanity through the process of Akashic Reading.

## **Sec. 2. Policy.**

I am issuing a national call to action to:

- a. Organize regular Akashic Reading workshops across all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of Kailasa, and sixty-four Sovereign orders of Kailasa.
- b. Consolidate all resources to innovate digital solutions to reach the Akashic Reading to a larger footprint and to facilitate Akashic Reading services via various social media platform;
- c. Increasing access to Nithyananda Hindu University to all citizens of e-Kailasa for them access the complete courses on the science of Akashic Reading
- d. Provide a comfortable, smooth, user-friendly registration process to access the Akashic Reading sessions
- e. Promote awareness campaigns to educate Hindus on the benefits and authenticity of the science of Akashic Reading
- f. In strict compliance with the - all knowledge is free - clause of - Paramashiva economic policy - laid down in the Veda Agamas, all wealth manifestation

services of Kailasa will be free of charge. The citizens and beneficiaries would be free to offer any donation amount or none based on their free will.

**Sec. 3. Establishment of a KAILASA's Akashic Reading Working Group.** The KAILASA's Akashic Reading Working Group is hereby established to facilitate an all inclusive effort for all Hindus as per this executive order. The Working Group will be co-chaired by the Secretary of Department of Religion and Worship, his designee and secretary of Department of Enlightened Civilization, or his designee. The Working group shall be composed of representatives from the departments of the Ministry of Sovereign, Global Communication, Human Services, and the Office of Management and Budget (OMB). Representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. Group members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

**Sec. 4. Responsibilities of KAILASA's Akashic Reading Working group**

Within one week of the date of this order, Akashic Reading Working group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to the Akashic Reading workshop. This Department of Enlightened Civilization shall be responsible to collect and compile reports from all Samrajyams (kingdoms), Sarvajnanapeethams (spiritual kingdoms) and de facto embassies of KAILASA with complete statistics of the number of Hindus that have been benefited through the Akashic Readings with their feedback.

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
