Celebrating Hindu Feminism by reviving traditions and rituals associated to Shakta Sampradaya to its original vigor and richness through Nithya Chandi Homa

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and agamas, it is hereby ordered as follows:

Section 1. Purpose. Hinduism or Sanatana Hindu Dharma, is the pure and irrefutable Cosmic Science of Superconscious living, as revealed in the VedaAgamas. My administration and KAILASA is committed to practice the underlying principle of Hinduism – Universalism – the absolute, in the idea that we are all part of the Oneness (Advaita) of this cosmos and anyone and everyone irrespective of their nationality, race, skin color, gender or any other skin-deep references can experience the state, space, powers and being of Paramashiva. Hinduism supports the rights of everyone to practice their path to Oneness with the divine. However, a long saga of heinous conspiracy and attack against Hinduism has been carried out by the anti-Hindu Nexus with the deliberate intention of annihilating Hinduism from planet Earth. Even during these conflicting times with the ongoing persecution against Hinduism, Kailasa continues to work towards the unified goal of Universalism through various ancient Hindu rituals such as (but not limited to) Nithya Chandi Homa which focuses on the destruction of anti-Hindu elements, and to resurrect Sanatana Hindu Dharma to its original vigor and richness.

Nithya Chandi Homa is a Vedic fire ritual invoking the grace of the most healing and grace-showering Cosmic Feminine form, Devi. She is the embodiment of all power, abundance and knowledge. Devi Chandi eradicates all negativities which restrict the manifestation of an individual's reality and blesses the individual to manifest;

- 22. Get the Atmajnana Enlightenment itself.

Sec. 2.Resposnsibilites of KAILASA's Department of Religion and Worship.

The KAILASA's Department of Religion and Worship is entrusted to create a platform for all Hindus to practice the religion with authenticity through various Hindu rituals such as Nithya Chandi Homa for the resurrection of Shaakta Sampradaya to its original vigor and richness and the wellbeing of all practising Hindu and all of humanity. The Secretary of the Department of Religion and Worship, or his designee shall work with the Department of Human Services, the department of information and broadcasting, and the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Department of Religion and Worship shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

Within one week of the date of this order, the Department of Religion and Worship shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with the access to Hindu rituals. This Department of Religion and Worship shall be responsible to collect and compile reports from all Samrajyams (kingdoms), Sarvajnanapeethams (spiritual kingdoms) and de facto embassies of KAILASA with complete statistics of the number of humans that have been benefited through the Nithya Chandi homa with their feedback.

Sec. 3. Policy.

I am issuing a national call to action to:

 In coordination with the Department of Religion and Worship, all seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA;
(i) Organise and facilitate the performance of Nithya Chandi Homa (Performing Chandi Homa Everyday)

(ii) Provide digital services to all practising Hindus to participate in Nithya Chandi Homa

(iii) Practice the authentic ritual of Nithya Chandi Homa in strict compliance with the Veda Agamas.

(iv) Any living and practising Hindu can support this initiative by contributing just one unit of the respective local currency

- 2. The Department of Religion and Worship shall distribute the authentic manual of Nithya Chandi Homa and the Devi Mahatmyam to all seventeen nations of KAILASA all Samrajyams (kingdoms), Samasthaanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA
- 3. The Department of Information and Broadcasting shall promote the benefits of Nithya Chandi Homa on all social media platforms to enrich all 2 billion Hindus to participate in this powerful homa.

Sec. 4. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
