

## Empowering and elevating the Youth of today's generation into the Leadership Consciousness

**Section 1. Establishment and Membership.** Hereby Kailasa is establishing the Yuva Nithyanandam Commission. The Commission's membership shall be composed of not more than ten members, appointed by the Supreme Pontiff, including members of the Sovereign Order of Kailasa, representatives from the ShriKailasa Uniting Nations for Mental Health and Development and Department of Health. The Supreme Pontiff shall designate a Chair from among the ten members of the Commission appointed by the Supreme Pontiff.

**Sec. 2. Mission.** My Administration has prioritized support for the science of Yuva Nithyanandam so that more students have access to this valuable option, providing students with rigorous education of the science that holds them to high standards.

The science of Yuva Nithyanandam is to convey to young people for their courage and contributions, the goal of the event is to inspire girls and boys to recognize their potential for leadership -- as educators, advocates, peer-mentors, artists and entrepreneurs -- and to appreciate that they can be leaders in their own way and in their own style.

In carrying out its mission, the Commission shall:

- a) Develop empowering sessions to educate the youth and next generation on the science of Yuva Nithyanandam
- b) Outline a plan to offer solid courses suited to a wider range of young Hindus to enable the flowering of the leadership consciousness within each individual.
- c) Continue to find innovative ways to link acharya expertise in this science, courses on this science, organize and facilitate digital sessions to people who need help.
- d) Increase the availability of educational measures on the importance of Yuva Nithyanandam in promulgating this knowledge of reaching the highest potential and installing the leadership consciousness as described in "Vijñāna Bhairava Tantra, Sutra 54, Dhāraṇa 31

I am the abode of the three bodies of shristi, manifestation, sthiti, maintenance and samhāra, dissolution, absorption for rejuvenation. From My increasing and expanding effulgence (from the Third Eye), the life-filled energy (vīryam) pervades as light to all. That (viryam) is the complete knowledge, pure, and the greatest core of the Netra, the Divine Eye. This is called the Mrityunjaya, the conqueror of death and is the giver of complete completion, liberation, mokṣa to ALL beings.

- e) Necessitate the release of this science of yuva Nithyanandam to today's children and youth in order to provide more safety, stability, and opportunity, placement with the world and provide a positive outlook on life.
- f) In strict compliance with the - all knowledge is free - clause of - Paramashiva economic policy - laid down in the Veda Agamas, all Nithya Dhyana Spurana services will be absolutely free of charge. The citizens and beneficiaries would be free to offer any amount in donation or none based on their free will.

**Sec. 4. Commission Decision-making.** The Commission shall endeavour to make any decision on an action or determination under the direction of Veda-Agama principle, specifically Kirana Agama, Yoga Pada with integrity, which shall be deemed to exist where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Kailasa.

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its

departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
