

Advancing Safe Motherhood and Protecting Newborn with the Empowering Science of eN-Pregnancy

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. My administration and KAILASA recognize the practice of conscious birthing with its benefits extending to the parents and the infant's wellbeing. In 2017, approximately 810 women died from preventable causes related to pregnancy and childbirth, with an additional 1 million children dying each year due to preterm birth complications. The Sovereign Order of Kailasa is committed to their obligations of reducing the number of premature infants or infants with disabilities who require immediate medical conditions and the number of women who die as a result of complications during and following pregnancy and childbirth through the eN-Pregnancy program.

In the Vedic times, conception and pregnancy were a conscious process that brought highly evolved souls to the planet. eN Pregnancy is the Kailasa administration's effort to revive this Vedic science of creating a 'NewGen' of enlightened human beings. eN-Pregnancy empowers parents to be genetic engineers of their child, perceiving pregnancy as a conscious choice. Humanitarian initiatives related to eN-Pregnancy enable the mother and the child's psychological and emotional well-being through various Hindu techniques. Few vedic techniques not limited to Nithya YogaSM, Nithya KriyaSM, Science of CompletionSM, Meditation, visualization techniques, mantra chanting, and Garbha Samvaada (communing with the unborn child), which prepares the infants body with positive bio-memories to attract an enlightened and intelligent soul. At the time of delivery, the newborn is born with extraordinary health, immunity, good weight, and growth with high IQ (intelligence quotient), EQ (emotional quotient), and SQ (spiritual quotient). The Federal Government of Kailasa has also been working towards making the sacred science of conscious birthing from the Garbha Upanishad available to all practicing Hindus.

Sec. 2. Policy. During these challenging times where globally, prematurity is the leading cause of death in children under the age of 5 years and with increasing preterm birth rates and infertility rates, pregnant mothers associated with clinical depression, ADHD, Autism, autoimmune disorders, early-onset hypertension, Diabetes mellitus, Coronary artery disease, depression on the rise in younger

generations, KAILASA's Department of Health aims to prevent deaths and complications from preterm birth through various Hindu techniques. This order will empower Hindu families who answer the call to open their hearts and homes to create the perfect receptacle for the ultimate landing of the intelligent soul. - starting with a healthy pregnancy

I am therefore issuing a national call to action to:

- (a) All 1500 defacto embassies of Kailasa and sixty-four Sovereign Orders of Kailasa to;
 - (i) facilitate completion classes in-person to educate various techniques, methods of completion that are initially revealed by Paramashiva and revived for all expecting Hindus.
 - (ii) Organize daily meditations, ritualistic workshops and yoga workshops for the wellbeing of the pregnant mother and unborn child
 - (iii) Organize workshops to explore the inner world possibilities through the practice of Vedic Truths.
 - (iv) Establishment of immediate workshops for all Hindu parents to be educated and initiated into the Four Tattvas, the core principles of life, Integrity, Authenticity, Responsibility, and Enriching.
 - (v) The Sovereign Order of Kailasa to permit, encourage, and facilitate the enrollment of all e-citizens of Kailasa in the Nithyananda Hindu University's eN-Pregnancy course
- (b) The Department of Health shall immediately develop a training module to equip the acharyas (teachers and moderators) by providing them with the right tools to cater to all 2 billion Hindus worldwide.
- (c) Increase the availability of Kailasa's digital services by exploring innovative digital technology solutions to reach all practicing Hindus.
- (d) The International agency, ShriKailasa Uniting Nations for Enlightened Birthing and Pregnancy shall facilitate a cosmic airport (High energy zones that radiate the state, space and powers of paramashiva) in all seventeen KAILASA nations - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA for the divine souls to land.
- (e) The Department of Human Services shall enrich all Hindus to practice this science of eN-Pregnancy for painless delivery of a divine child and enrich

Sannyas (initiated into Hindu monkhood) doctors to pursue this field of study.

- (f) The Kailasa Government is organizing under the international agency structure of the “Yellow Om” global agency structure, reaching out to all citizens and providing yogic, ayurvedic solutions.

Sec. 3. Membership and Establishment of a KAILASA’s eN-Pregnancy Group The Kailasa’s eN-Pregnancy Working Group established to deliver a world “where every childbirth is safe” effort to avail the science of conscious birthing to all Hindus. The Secretary of the Department of Health shall ensure that individuals responsible for all eN- Pregnancy programs and activities under their jurisdiction are aware of their obligations toward infants and pregnant mothers. In particular, the Secretary of the Department of Health and the Secretary of the Department of Human Services shall ensure that individuals responsible for such programs and activities are aware that compliance with these obligations is mandatory, including the obligation to provide an appropriate combination of the ancient Vedic practices and modern medicine endorsing the truth that every Vedic method is scientific to its root, with evidence. The Secretary of the Department of Health and the Secretary of Human Services shall, as appropriate and consistent with applicable law, prioritize the allocation of proper resources to programs and activities, including hospitals, that provide training to medical personnel regarding this science of eN-Pregnancy.

The working group will be collaborating with the secretary of Department of Human Services and the executive director of ShriKailasa Uniting Nations for Enlightened Birthing and Pregnancy. The Working group shall be composed of representatives from the Department of Ministry of Sovereign, the department of global communication, and the Department of Environment and Animals, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All Working Group members shall be full-time or permanent part-time, officers or subjects of the Federal Government of KAILASA.

Sec. 4. Responsibilities of the Kailasa’s eN- Pregnancy Working Group. Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with the access to the eN-Pregnancy program. The working group also shall propose a schedule of the classes for the entire pregnancy course to be published on the government website and social media platforms.

Sec. 5. General Provisions.

a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. The Director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
 - a. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
