## Eradicating the Problems of the Outer World by Empowering and Cleansing the Inner Being

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and agamas, it is hereby ordered as follows:

**Section 1. Policy**. Most problems faced by humanity today exist in all levels of their being – unconscious, conscious and subconscious. Critical problems are rooted in the subconscious and unconscious levels of the being resulting in physical, mental and emotional health conditions. It is Kailasa's Dharmic responsibility to guide humanity and offer Hindu solutions in accordance with the Veda agamas for the problems faced by humanity.

The Nithya Kriya Yoga (NKY) is a meditation program that unleashes the 'blissful living' by creating the space within oneself to liberate from ingrained and unconscious emotions like guilt, desire, fear, pleasure and pain by cleansing the 5 Koshas (5 energy bodies which cover the Soul or Ultimate Self) which are responsible for such emotions. The Nithya Kriya Yoga program is designed to uproot the engraved memories of the past, providing a new life for all of mankind which is driven by natural intelligence and spontaneous enthusiasm.

The Federal Government of Kailasa is committed to providing humanity with the knowledge and clarity to take control of all the happenings in their life by eradicating the fundamental problem faced by most youth in today's world – Low Self Esteem. Research shows that 75% of high school girls with low self–esteem reported engaging in negative activities like cutting, bullying, smoking, drinking, or disordered eating. My administration and Kailasa aims to employ Vedic techniques to cleanse the Koshas and ingrain the fundamental cognition of prioritizing self–love. Nithya Kriya Yoga is a humanitarian and spiritual initiative led by Kailasa to transform each Hindu to start loving themselves to achieve a blissful life.

## It is the policy of Kailasa to;

(a) Organise spiritual counselling workshops to enrich and educate the 2 Billion Hindus around the world about the importance of kosha cleansing in collaboration with ShriKailasa Uniting Nations for Consciousness Studies and Practise.

- (b) The Department of Education shall develop a manual for all inspired acharyas (teachers) to equip them with the right tools required to conduct the Nithya Kriya Yoga program for a wide range of interested participants
- (c) The Department of Information and Broadcasting shall enrich and empower the 2 billion Hindus and all of humanity to participate in the Nithya Kriya Yoga program by promoting the benefits of the program
- Sec. 2. Establishment of a Kailasa's Nithya Kriya Yoga Working Group. The Kailasa's Nithya KriyaYoga Working Group is hereby established to facilitate a "Blissful life" effort to avail Nithya Kriya Yoga to all Hindus. The Working Group will be co-chaired by the Secretary of Department of Education, or his designee, and the Secretary of Department of Human Services, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), ShriKailasa Uniting Nations for Consciousness Studies and Practise, and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.
- Sec. 3. Responsibilities of the Kailasa's Nithya Kriya Yoga Working Group. Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with the access to Nithya Kriya Yoga program. The Working group shall submit a consolidated report to the presidential executive office regarding the schedule and the number of people benefitted through the program.
- **Sec. 4. General Provisions**. a. Nothing in this order shall be construed to impair or otherwise affect:
  - i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

c.	This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
