## Will of the Hindus shall Decide the Future of Hinduism.

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

**Section 1. Purpose**. To establish the voting structure of the Federal Government of Kailasa's Hindu Parliament, introducing the system and the criteria for the voting rights for all the Hindu citizens. Article 21 of the Universal Declaration of Human Rights of the United Nations states that everyone has the right to participate in the government. The people's will shall be governmental authority. The peoples will be implemented in periodic and genuine universal elections. Equal suffrage and shall be held by secret ballot or by equivalent free voting procedures. Reserving the fundamental human rights of each Hindu, Kailasa recognizes that all the initiated Hindus shall have the authorization and freedom to exercise their right to vote.

Anubhava Mantapa was the first hindu parliament in the history of mankind, elucidating the corroboration of the current Hindu parliament of Kailasa. This parliamentary house dealt with the myriad of issues pertaining to social, religious, spiritual, yogic psychological, economic and literary spheres, furthering with the human values and ethics. Every court hearing was systematically structured and implemented to record and preserve the proceedings of the house. The members and governance of the first Hindu Parliament were given the complete liberty to exercise their thought, speech and action.

The Kailasa's Hindu parliament is being revived as a prominent component of sanatana Hindu Dharma by the federal government of Kailasa, reconstructing the Hindu parliament with the base being the core principle of Responsible Democracy, where all Kailasa citizens are informed, introduced, and involved in different fields and given voting rights. The Federal Government of Kailasa is taking this opportunity to bring forth the issues about Hinduism. Hindus will decide Hinduism's future through the voting system. Hinduism's collective self-rule shall be established and fostered through a free, fair, accessible, and secure voting system through which the Kailasa government will hear the voice of every eligible Hindu.

**Sec. 2. Policy.** It is the Kailasa Nation's policy to commence the activities of Hindu Democracy, the Hindu Parliament and Governance of Kailasa, for the public.

I am therefore issuing a global call to action for all Hindus to:

- a. Engage the resources of Federal Government of Kailasa to facilitate a fair, secure and accessible voting process, including by:
  - i. Kailasas's Nation is to provide a comfortable, seamless registration method for Kailasa e citizenship.
  - ii. Kailasas's Nation is a systematic plan regarding the rules promulgating according to the procedure and pre-requisites needed for participating in the voting system.
  - iii. Kailasas's Nation will campaign for educational measures to increase awareness of voting topics to all the Hindus.
- b. Increase the availability of Kailasa's services, i.e., Facilitate the complete Kailasa's Hindu vote online by digitalizing the entire procedure and prerequisites for the casting of the vote.
- c. We provide voting rights to people who are not in the Sovereign Order of Kailasa but are active in Hinduism through books, posts, and social media and participating in the Kailasa's Hindu parliament.
- d. Design civic engagement tools to encourage ALL Hindus to vote and decide for the future of Hinduism.
- e. Mobilizing resources and implement innovative solutions to provide voting services remotely, leveraging hi-tech and low-tech approaches.

**Sec. 3. Establishment of a Kailasa's Hindu parliament Working Group.** The Kailasa's Hindu Parliament Working Group members will facilitate an "all-of-government" effort to emphasize the structure of The United States of Kailasa's voting system to all Hindus. The Working Group will have the Secretary of Department of State as his presiding officer, his designee, and the Secretary of Department of Human Services, or his designee. The Working Group members shall comprise of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, and the Department of Global Communications. Representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All Working Group members

shall be full-time or permanent part-time, officers or subjects of the Federal Government of Kailasa.

**Sec. 4. Responsibilities of the Kailasa's Hindu parliament Working Group.** Within 24 hours of this order's date, the Working Group shall develop and submit to the Supreme Pontiff a report. There shall be a primary executive branch to keep the mission's pace to help fulfill these responsibilities. The executive branch will provide effective, efficient, and authentic information that outlines a plan for service coordination between all relevant stakeholders and administrative departments and agencies (agencies) to provide Hindus the right education by exercising the law of responsible democracy to cast their vote.

**Sec. 5. General Provisions**. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. The director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
