Empowering Humanity from Mental health and establishing global peace through, project: Atma Linga Spiritual Healing

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. In many countries, people do not have access to basic mental health care and treatment they require. In others, the absence of community based mental health care means the only care available is in psychiatric institutions which are associated with gross human rights violations including inhuman and degrading treatment and living conditions. Through the project of atma linga spiritual healing the physical, mental and social well-being are assured for every Hindu.

Atmalinga Spiritual Healing is a Hindu holistic healing method practiced by the initiated disciples manifesting the power of spiritual healing for the welfare of all beings. Atmalinga Spiritual Healing is free of cost and helps remove negativities in the physical, mental, psychological and spiritual planes. Atma Linga, spiritual healing for global health and Global peace. This is the unique spiritual project Shrikailasa is launching. Atma Linga spiritual healing for global health is a twenty one day global initiative by ShriKailasa uniting nations for affordable and holistic health care, to provide physical, mental, psychological and spiritual healing to all the 2 billion Hindus.

The Atma Linga spiritual healers will be the initiated disciples who have received the Shiva Deeksha and Atma Linga and aim to provide healing for the wellbeing of humanity. My Administration is taking action to empower all the Hindus to involve their time, treasure, energy to actively join this global service to instate proper health and global peace.

Sec. 2. Membership and Establishment of a KAILASA's Nithya Spiritual Healing Group.

KAILASA's Atma linga spiritual healing working groups are established to help and provide all humans the healing and the science of this healing to proliferate healers who with this knowledge are qualified to heal themselves and others, the base foundation being to promote world peace by eradicating mental and physical health problems . The working group will be chaired by the Secretary ofHuman Services or his designee. The Working group comprises representatives from the following

Departments: Ministry of Sovereign, Global Communication, and Office of Management and Budget (OMB). Representatives of other executive departments, agencies, and offices of Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. Working Group memes shall be full-time, permanent part-time, officers or subjects of the Federal Government of KAILASA.

Sec. 3. Committee Decision-making. The Committee shall endeavor to make any decision on an action or determination under the direction of the Veda-Agama principle, specifically Kamika Agama, Purva Pada with integrity, which shall be deemed to exist where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Kailasa.

Sec. 4. Implementing Measures and policies.

It shall be the policy of the executive branch to advance the project of atma linga spiritual healing that create high-quality healing experience for all Hindus and give the opportunity to conduct the healing themselves and, and strengthen economic growth. The members shall be appointed by the approved committee and drawn from the public with relevant experience or subject-matter expertise to represent the importance and knowledge of the atma linga spiritual healing.

I, therefore, am issuing a national call to action to:

- (a) In coordination with the Department of Human Resources, all seventeen nations of KAILASA – all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA shall:
 - Organize and facilitate the atma linga spiritual healing project to people interested in receiving and learning the science of healing.
- (b) Provide Spiritual healing to minimum 5 new people every day for 21 days.
- (c) Declare and create the Sankalpa by wearing a Sacred Yellow thread from Swamiji's
- (d)Chant the Mahavakya, "Om Nithyananda Paramashivoham" 21 days times a day.
- (e) Chant Shiva Moola Mantra 21 times a day.

- (f) Facilitate and organise workshops to witness the daily Nithyananda Satsang.
- (g) Enrich and cause more Atmalinga Spiritual healers for promulgating and working towards the unified goal to instate Global health and world peace.

Sec. 5. Responsibilities of the KAILASA's Atma linga spiritual healing Working Group. Within one week of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with access to free mental, emotional, psychological and spiritual health services. This Working Group shall collect and compile reports from all Samrajyams (kingdoms), Sarvajnanapeethams (spiritual kingdoms), and KAILASA's de facto embassies complete statistics of the number of humans that have been impacted by these services and their feedback. SHRIKAILASA Uniting Nations of Affordable and Holistic Healthcare is organizing a 21-day global healing campaign for Global Health.

Sec. 6. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. The Director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
