

Building Prosperity and Supporting a Sustainable Future to Alleviate World Hunger and Promote Food Security

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. My administration and Kailasa aims to bring food assistance to more than 12 million people in 80 countries and is continuously responding to emergencies. After decades of steady decline, world hunger has been rising at a slow pace since the year 2015. An estimated number of 821 million people in the world suffered from hunger in the year 2018. Global demand for food has increased steadily, along with the world's population growth, record harvests, new technologies, improvements in incomes, and diet diversification. The Federal Government of Kailasa is working on some of the components of the goals:

- Ending hunger and ensuring access to safe and nutritious food for all Hindus;
- Removing all forms of malnutrition;
- Doubling the agricultural productivity and incomes of small-scale food producers;
- Providing sustainable food production systems;
- Increasing investment in agriculture;
- Correcting and preventing trade restrictions and distortions in the world agricultural markets;
- Adopting measures to ensure the proper functioning of the food commodity market.

Sec. 2. Policy. The federal government of Kailasa's priority is to protect people from hunger and extreme poverty. The Sovereign of Kailasa order aims to ensure that people have continuous access to high-quality food, which leads to active and healthy lifestyles. The three main goals:

- the eradication of hunger, food insecurity, and malnutrition
- the elimination of poverty and the driving forward of economic and social progress for all
- the sustainable management and utilization of natural resources, including land, water, air, climate, and genetic resources for the benefit of present and future generations

I am therefore issuing a global call to action for all Hindus:

1. All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms) all their branches, all the 1,500 de facto embassies of KAILASA and sixty-four Sovereign orders of KAILASA empowered with 10 million peacekeepers shall:
 - a. Work with all Hindus and citizens of their nation, organizing under this banner reaching out to all citizens in providing social services
 - b. Immediately resume (if stopped), and expand all their Annadaan (organic vegetarian free food offering) services.
 - c. Enacting on the emergency clauses of - No Hungry Human Act
 - d. To increase domestic production, giving priority to perishable food items.
 - e. To increase the allocation of human resources
 - f. To facilitate novel food distribution mechanisms such as food packets so that the - "Nobody seeking food shall be refused of food" - clause of the "No Hungry Human Act" is upheld, even during the COVID-19 pandemic.
2. To increase allocation of agricultural lands for cultivation by executing the Presidential Executive Order 10017 - dated 2 April 2020 - "To utilize every possible inch of land throughout the kingdom of KAILASA for cultivation.
3. KAILASA Food Bank shall collaborate with ShriKailasa Uniting Nations for Nutritious Food and Hunger Free World shall take responsibility to maintain high integrity to procure pure sattvik (rejuvenating) and organic food to feed people on a large scale and incorporate holistic health.
4. The Federal government of Kailasa mainstreams nutrition in their distribution of food.

Sec. 3. Establishment of a Kailasa's Annalaya Working Group. The Kailasa's Annalaya Working Group is hereby established to facilitate an "all-of-government" effort to organize Annadhan to all the Hindus. The Working Group co-chaired by the Secretary of Department of Agriculture and Food, his designee, and the Secretary of the Department of Human Services, or his designee. Working Group members shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), ShriKailasa Uniting Nations for Nutritious Food and Hunger Free World, and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate the concurrence of the head of the department,

agency, or office concerned. All Working Group members shall be full-time or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Sec. 4. Responsibilities of the Kailasa Annalaya Working Group. Within 24 hours of this order's date, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the right to sattvic and nutritious food.

Sec. 5. General Provisions. a. Nothing in this order is construed to impair or otherwise affect:

1. the authority granted by law to an executive department or agency, or the head thereof; or
2. the Director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
3. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
4. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
