

KAILASA's Bachelor's Degree in Living Enlightenment - Making Enlightenment Just One Click Away

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section. 1. Purpose. The purpose of this order is to provide the science of Enlightenment to all practising Hindus and the entire humanity. The science of Living Enlightenment as revealed by Paramashiva in the Vedagamas is the only solution for all problems faced by humanity. The Federal Government of Kailasa recognises the need to preserve, protect and practice the sacred science of Living Enlightenment due to its ability to provide a superconscious breakthrough for the whole of humanity. My administration and Kailasa has made the science of Living Enlightenment freely available to the whole of humanity in compliance with the Vedagamas through the Nithyananda Hindu University's Bachelor's Degree in Living Enlightenment.

Sec. 2. Policy. It is the policy of Kailasa to provide and facilitate residential students free food, accommodation clothing and knowledge for all enrolled Hindus to manifest the State of Paramashiva, Space of Paramashiva, Powers of Paramashiva, Being of Paramashiva and Super Consciousness of Paramashiva. Kailasa also offers free digital Living Enlightenment courses to the inspired Hindus with lack of resources to study in the existing campuses. I, hereby, mandate all practising Hindu to receive a Bachelor's Degree in Living Enlightenment. The Federal Government of Kailasa shall;

(a) Accommodate all practising Hindus enrolled in KAILASA's Bachelor's Degree in Living Enlightenment in all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches and all the 1,500 de facto embassies of KAILASA.

(b) Enrich and enreach all practising Hindus to start radiating Living Enlightenment by enrolling themselves to KAILASA's Bachelor's Degree in Living Enlightenment.

(c) In collaboration with ShriKailasa Uniting Nations for Education Reform and Development, help de facto embassies in mobilizing resources and implementing innovative and context-appropriate solutions to provide the bachelor's degree remotely, leveraging hi-tech, low-tech, and no-tech approaches

(c) In strict compliance with the - all knowledge is free - clause of - Paramashiva economic policy - laid down in the Veda Agamas, the KAILASA's Bachelor's Degree in Living Enlightenment will be absolutely free of charge. The citizens and beneficiaries would be free to offer any amount in donation or none based on their free will.

Sec. 3. Membership and Responsibilities of Nithyananda Hindu University. Within 24 hours of the date of this order, the Working Group, along with the executive director of ShriKailasa Uniting Nations for Education Reform and Development, shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with access to the 3 - years Bachelor's degree in Living Enlightenment and produce the report on the number of students successfully graduating the 3-ye program.

Sec. 4. Committee Decision-making. The Committee shall endeavour to make any decision on an action or determination under the direction of Veda-Agama principle, specifically Kamika Agama, Purva Pada with integrity, which shall be deemed to exist where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Kailasa.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
