

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in vedas and agamas, it is hereby ordered as follows:

**Section 1. Policy.** My administration and Kailasa is committed to spiritually enrich and enreach the Hindus all around the world, restoring and reviving our culture and civilization based on authentic Hinduism. Maheshwara Puja is Hinduism's most ancient ritual. Through this puja, all ancestors are blessed to attain liberation and offer them "pinda" or food for the journey to their liberation.

Maheshwara Puja is performed for intense completion with anyone who has left their body and passed into their new life in a new body, new ambience but with same incompletions from a Karmic level. To experience a sudden shift and liberation and all auspiciousness in their lives.

That is, the jataraagni (digestive fire), the hunger fire of a sannyasi is the best fire into which you can offer the pinda tharpana. The shraaddha (ritual offering to departed souls), reaches the pithrus (departed ancestors) directly. It is thousand times greater than offering any "shraaddha", any "pinda", in any river, any water-body, any lake, any holy land, any holy place.

Maheshwara Puja is offered in the memory of a person who is no more. It is offered so that the departed soul rests in peace. The real peace that a soul can experience is the space of Enlightenment. This ritual bestows the space of completion with all departed souls and hence the Hindu is liberated from all the incompletions and patterns related and created by the deceased soul. Sannyasis (members) of the Sovereign Order of Kailasa have no other desire or intention to get Enlightened and get their identity dissolved in the Cosmos. They become a pure channel for the Cosmos. So feeding them and offering Puja to them brings about the same effect in the departed soul and helps them attain enlightenment and get merged with the Cosmos.

I am therefore issuing a global call to action for all Hindus to:

- a. All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty four Sovereign Orders of KAILASA empowered with 10

million peacekeepers shall work with the ShriKailasa Uniting Nations for Ancient Rituals to:

- Facilitate the ritual of Maheshwara Puja for all seeking Hindus
- Develop educational measures to increase awareness on the need of Maheshwara Puja and how it helps bring the space of completion in the lineage
- Provide the required manuals and items for the offering of the puja
- Ensure daily ritual of Maheshwara Puja is digitalized on all platforms of social media to enrich and enreach all the 2 billion Hindus for offering Pada Puja.

### **Sec. 3. Responsibilities of a Kailasa's Department of Religion and Worship.**

The Kailasa's Department of Religion and Worship is hereby established to facilitate an "all-of-government" effort to liberate all the souls with completion through Maheshwara puja. The Working Group will be co-chaired by the Secretary of Department of Religion and Worship, or his designee, and the Secretary of Department of Human Services, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), ShriKailasa Uniting Nations for Ancient Rituals, and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Within 5 days of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the opportunity to involve in the revival of Hindu Sanatana Dharma through Maheshwara puja.

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
