

# Recognising the Universal Declaration of Animal Welfare: Protecting Cows From Cruelty

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in vedas and agamas, it is hereby ordered as follows:

**Section 1. Purpose.** In the name of white revolution exotic cows and cross breeding destroyed indigenous cow breeds, due to the substantial growing concern of the invasive slaughterhouses being the causative agents of disease, which threaten human, animal, and plant health. The introduction, establishment, and spread of factory farmhouses and slaughterhouses create the potential for serious public health impacts, especially when considered in the context of changing climate conditions. Modern India boasted of huge revenues from cattle slaughter and exports supported by huge industrialized slaughter houses in major cities of India. Anti-Hindu forces and vested groups from the international arena have influenced politics and deliberately hurt the sentiments of Hindus by executing ruthless cow slaughter. In total, more than 300 million cows were slaughtered for food in 2016 according to the United Nations. My administration and Kailasa recognises the benefits of campaigning the vegetarian lifestyle for the planet and reviving the glorious agrarian based society of Vedic era of Bharat.

The Federal Government of Kailasa is here to protect the Cows around the world and restore the germplasm of indigenous cows, restoring the glory and importance of the indigenous breeds. We are committed to help and provide ethical treatment to all the cows to promote the core belief of Sanatana Hindu Dharma that the divine exists in every living being. The Federal Government of Kailasa is committed to the restoration of the reverence and cultural importance of cows as Gaumatha. To implement our commitments to actions, Kailasa has established the Gaushala, raised its status to Mandir, temple and addressed it as KAILASA's Nithyananda Gaumandir.

KAILASA's Nithyananda Gaumandir - is a Gaushala (cow shelter) established to bring back the glory of the indigenous breeds. This breed of cows were developed by the great Rishis of Vedic era, to nourish and serve the ritual needs of Hindus.

**Sec. 2. Policy.** It is the policy of the Federal Government of Kailasa to promote the introduction, establishment, and spread of KAILASA's Nithyananda Gaumandir. I am therefore issuing a global call to action for all Hindus to:

- a. All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty four Sovereign orders of KAILASA empowered with 10 million peacekeepers shall
  - i. Restore and revive the established indigenous cow breeds.
  - ii. Adopt Vedagamic principles of animal husbandry management and agricultural practices.
  - iii. Build shelters for cows which are rescued from slaughter.
- b. Creating a safe haven for all the cows by building and conserving secure shelters with fresh water, safe food and veterinary medical supervision.
- c. Spread the knowledge of Satya Yuga as evidenced in Vedic, Agamic scriptures, where cows are treated with superlative care and are given reverence as a deity.
- d. The Federal Government of Kailasa envisions 5000 indigenous Cows in the KAILASA's Nithyananda Gaumandir and showcasing to the world as the best Gaushala and a place for the happiest cows kept as per the Vedagamic instructions.

**Sec. 3. Establishment of a KAILASA's Goshala Working Group.** The KAILASA's Goshala Working Group is hereby established to facilitate an "all-of-government" effort to protect cow welfare as per the Vedic scriptures. The Working Group will be chaired by the Secretary of Department of Environment and Animals, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

**Sec. 4. Responsibilities of the KAILASA's Goshala Working Group.** Within 24 hours of the date of this order, the Working Group shall develop and submit to the

Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to advance the establishment of Goshalas around the world, and promote peaceable environment for all the animals.

**Sec. 5. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
