

Science of Wealth Manifestation : To Eradicating Poverty among Hindus and the Entire Humanity

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Section 1. Purpose. My administration and Kailasa is committed to create a world which is free from poverty. Approximately 1.2 billion people in the world live in extreme poverty. Global poverty shoots up not because the wealthy are accumulating what they can enjoy, but because money is blocked and kept in hiding, stacked away, without being used for enjoyment or growth of society. We are committed to helping and providing all humans spiritual counselling and supporting human beings mentally, emotionally and psychologically especially during these hard times of the recent recession due to COVID-19 which is predicted to be the deepest since 1945-46, and more than twice as deep as the recession associated with the 2007-09 global financial crisis. The Kailasa Administration has established wealth manifestation programs and modules to help desperate families attract wealth via various Hindu techniques.

For the last 26 years, the Federal Government of Kailasa has created, maintained and expanded several humanitarian services providing the science of wealth manifestation to all Hindus and the entire humanity. Kailasa aims to eradicate poverty from the world and expand the divine consciousness and help individuals experience their higher identity.

Sec 2. Policy. It is the policy of KAILASA, to live and demonstrate these principles of Veda Agamas as a lifestyle of each Hindu. I am therefore issuing a national call to action to:

- a. Promote wealth manifesting programs through various social media platforms to educate Hindus on the various Hindu ancient techniques for wealth manifestation
- b. Consolidate all resources to innovate digital solutions to reach the science of wealth manifestation to a larger footprint.
- c. Increasing access to Nithyananda Hindu University to all citizens of e-kailasa for them access the complete courses on the science of wealth manifestation
- d. Providing an easy, seamless registration method to enroll into the wealth manifestation workshops through different social media platforms
- e. All 1500 defacto embassies of Kailasa and sixty four Sovereign Orders of Kailasa to;

- (i) Organize daily wealth manifestation workshops, ritualistic workshops such as but not limited to free Lakshmi Puja;
- (ii) Organising in person and digital workshops to cater to all 2 billions Hindus.
- f. Facilitate and educate Hindus on the practice of various Hindu techniques such as but not limited to
 - (i) Brushing teeth with haritaki in early morning with an intention to manifest wealth
 - (ii) Brushing teeth with neem stick
 - (iii) Every day during sunset, light a lamp with sesame oil, clarified butter or pure ghee, with the wick facing either North, East or West.
 - (iv) Organise a session with chanting of the Mahalakshmi Mantra, “Om Shreem Mahalakshmi Namaha” 21 or 108 times every day during sunrise and sunset.
 - (v) Chanting or playing of the powerful Dhanakarshana Bhairava Mantra
 - (vi) Looking at the Sri Yantra for 21 minutes everyday
 - (vii) Making a declaration manifesting wealth during the Brahma Muhurta time (3am-6am)
- g. In strict compliance with the - all knowledge is free - clause of - Paramashiva economic policy - laid down in the Veda Agamas, all wealth manifestation services of Kailasa will be absolutely free of charge. The citizens and beneficiaries would be free to offer any amount in donation or none based on their free will.

Sec. 3. Membership and Establishment of a KAILASA’s Wealth Manifestation Group

The KAILASA’s Wealth Manifestation group is established to create “A poverty free world”. The working group will be co-chaired by the secretary of Dept. of Human Services, and the secretary of Department of Agriculture. The Working group shall be composed of representative from the Department of Ministry of Sovereign, the department of global communication, and the Department of Environment and Animals, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Sec. 4. Responsibilities of the Kailasa’s Wealth Manifestation Working Group.

Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to the science of wealth manifestation.

Sec. 5. General Provisions. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
