

Executive order 20004 of July 17, 2020

## **Establishment of International Agency White Om For Providing Psychological Healing, Spiritual Counselling and Superconscious Transformation For The Human Race**

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

**Section 1. Purpose.** Establishment of an international agency addressing the need for psychological healing, spiritual counselling and a superconscious transformation for the entire human race. We are committed to helping and providing all humans psychological healing, spiritual counselling, supporting human beings mentally, emotionally and psychologically.

The World Health Organisation (WHO) estimates that each year approximately one million people die from suicide, which represents a global mortality rate of 16 people per 100,000 or one death every 40 seconds. It is predicted that by 2020 the rate of death will increase to one every 20 seconds. A study, in April 2020, reported how some nations had seen a 3-fold increase in the prevalence of symptoms of depression compared to the previous year.

For the last 26 years, the Federal Government of KAILASA has created, maintained, offered and expanded several university courses, conferences, think tank groups, meditation and yoga workshops, enabling psychological and emotional well being, spiritual transformation and expansion of all its citizens, Hindus and the entire humanity. KAILASA shall continue working towards this goal, more so especially during the present time of COVID-19 pandemic, when the world is desperately looking for solutions for the inner world.

### **Sec. 2. Membership and Establishment of a KAILASA's White Om Group.**

The KAILASA's White Om working group is established to create an international agency for helping and providing all humans psychological healing, spiritual counselling, supporting human beings mentally, emotionally and psychologically.

The working group will be co-chaired by the secretary of Dept. of Human Services, or his designee. The Working group shall be composed of representative from the Department of Ministry of Sovereign, the department of global communication, and

the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of KAILASA.

**Sec. 3. Committee Decision-making.** The Committee shall endeavor to make any decision on an action or determination under the direction of Veda-Agama principle, specifically Kamika Agama, Purva Pada with integrity, which shall be deemed to exist where no Committee member objects to the proposed action or determination. The committee shall work directly under the supervision of The Supreme Pontiff of Hinduism and the Head of **Uniting States** of KAILASA.

**Sec. 4. Implementing Measures and policies.**

I am issuing a national call to action to:

- (a) In coordination with the Department of Education, all seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA
  - (i) Organize all manpower resources under the international agency structure of the 'White Om'.
  - (ii) Work with all Hindus and citizens of their nation, organizing under this international wing reaching out to all citizens in providing psychological healing, spiritual counselling, spiritual counselling, supporting human beings mentally, emotionally and psychologically.
  - (iii) Immediately expand the mental, emotional, psychological and spiritual services of KAILASA, such as but not limited to :
    - (1) Organizing KAILASA's Nithyananda University courses, conferences, such as but not limited to - The Paramashivoham 2.
    - (2) Organizing daily meditation, ritualistic worship (puja) and yoga workshops
    - (3) Organizing online sessions for one on one counseling sessions.
    - (4) Organizing special diet programs such as Pancha Pattini Vratam which increases immunity and reduces mental stress, to prepare the body of the citizens and all participants.
  - (iv) To increase the allocation of human resources in managing the health care of the citizens

- (v) In strict compliance with the - all knowledge is free - clause of - Paramashiva economic policy - laid down in the Veda Agamas, all services offer all services absolutely free of charge. The citizens and beneficiaries would be free to offer any amount in donation or none based on their free will.
- (b) The Department of Education shall
- (i) Offer classes and services for twenty four hours a day
  - (ii) Increase the Akashic Reading services
- (c) The Department of Sovereign Archives is instructed to organize, catalogue, publish all previous courses of KAILASA's Nithyananda University relating to mental, emotional, psychological and spiritual well beings, the in public domain, such as but not limited to :
- (i) All Presidential Addresses and University Lectures,
  - (ii) All Darshans
  - (iii) All Webinars
  - (iv) All programs such as - Nithya Dhyana Yoga, Atma Spurna Program, Nithya Spurna Program, All Darshans, Nithya Kriya Yoga (NKY), en-Relationships, en-Health, Life Bliss Engineering, Akashic Reading, Yoga Spurna Program (YSP), Healing Tower Service, Nithyananda Yoga, Nithya Arogya Yoga (NAY), Nithya Dhyana Spurana Program (NDSP), Nithya Dhyana, Living Enlightenment Process, Shakti Spurana Program, etc.
  - (v) **All programs for children** : Quantum Memory Program, en-Genius, Nithyanandam-Kids, etc.
- (d) The Department of Health shall use device novel means and increase manpower and time resources allotted for care of prenatal children and pregnant mothers by extending the en-Pregnancy services.
- (e) The Department of Rituals shall offer various fire rituals (Homas), Abhishekams, such as but not limited to
- (i) Nithya Chandi Homa, Kalabhairava Homa, Prathyangira Homa, Nithya Rudra Homa - all of which are known to heal mental disorders and bring completion and composure to the participants.
  - (ii) MahaKalabhairava Abhishekam, Nithyanandeshwara Paramashiva and Nithyanandeshwari Parashakti Abhishekam, etc.
  - (iii) Maheshwar Puja - for completion with departed souls

**Sec. 5. Responsibilities of the White Om Working Group.** Within one week of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus the access to free mental, emotional, psychological and spiritual health services. This Working Group shall be responsible to collect and compile reports from all Samrajyams (kingdoms), Sarvajnanapeethams (spiritual kingdoms) and de facto embassies of KAILASA with complete statistics of the number of humans that have been impacted these services and their feedback.

**Sec. 6. General Provisions.** a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
  - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against KAILASA, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
