## Ushering all Hindus to the Next level of Superconscious breakthrough

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of Kailasa, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

**Section 1. Purpose**. Deeksha or 'initiation' is direct transfer of spiritual energy from Paramashiva. Deeksha is revered in the Vedic tradition as the ultimate benefaction, that a master can confer upon his disciple on the spiritual path. A myriad of people have experienced miraculous healing of diseases, intellectual clicks, mystical occurrence from the living representative of Paramashiva in the form of various initiation such as initiation through Nayana (Sight), Mantra, (Sound) and/or Sparsha (Touch)

Deeksha results in the spontaneous awakening of the Kundalini, further initiating the chain to discover one's highest inner potential energy. Research in neuroscience has proved that deeksha floods the body and brain with Kundalini energy.

When Kundalini ascends the spine through the Sushumna Nadi (the main channel of subtle energy), it results in a huge energy influx into the brain. As it flows from the thalamus to the cortex, Kundalini commences a powerful energy loop within the brain which awakens the latent, non-mechanical parts. With increasing levels of coherence, the whole brain functions at its pinnacle, turning into a superconductor of conscious energies that heal, empower and transform lives. Enhanced awareness levels, greater creativity and extraordinary powers start to express: levitation, teleportation and materialization. This influx of superconscious energy also visibly slows down the ageing process and improves immunity to disease. The Federal Government of Kailasa is committed to providing all Hindus and the entire humanity an empowering and peaceful life, hence recognises the need for initiation

**Sec. 2. Policy.** It shall be the policy of the Federal Government of Kailasa to encourage Deeksha/Initiation for all the practicing Hindus as a fundamental need, in order to maintain the tradition of raising all hindus to the next superconscious level. I am therefore issuing a global call to action for all Hindus to:

a. Engage the resources of Federal Government of Kailasa to facilitate a coherent, secure and accessible deeksha initiation to all Hindus, including by:

- i. Provide a comfortable, uninterrupted registration method for 2 way conferencing for all the Hindus to receive the deeksha.
- ii. Kailasas's Nation will campaign for educational measures to increase awareness of deeksha/initiation topics to all the Hindus.
- b. Increase the availability of Kailasa's services, i.e., facilitate the complete Deeksha process online by digitalizing the entire procedure.
- c. The Federal Government must ensure that careful attention is paid to standardised procedures governing its provision of deeksha process to all the practising Hindus.
- d. Design civic engagement tools to encourage ALL Hindus to join the deeksha/initiation via 2 way conferencing such as: Paramashivoham level 2 program, Daily Nithya Satsang.
- e. To provide all initiated Hindus with the right to vote in Kailasa.

**Sec. 3. Establishment of a Kailasa's Deeksha Working Group**. The Kailasa's Deeksha Working Group members will facilitate an "all-of-government" effort to support all Hindus in receiving the Deeksha. The Working Group will have the Secretary of Department of human services as his presiding officer, his designee, and the Secretary of Department of religion and worship, or his designee. The Working Group members shall comprise the representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, and the Department of Global Communications. Representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All Working Group members shall be full-time or permanent part-time, officers or subjects of the Federal Government of Kailasa.

**Sec. 4. Responsibilities of the Kailasa's Deeksha Working Group.** Within 24 hours of this order's date, the Working Group shall develop and submit to the Supreme Pontiff a report. There shall be a primary executive branch to keep the mission's pace to help fulfill these responsibilities. The executive branch will provide effective, efficient, and authentic information that outlines a plan for service coordination between all relevant stakeholders and administrative departments and agencies (agencies) to provide every Hindu the innate right to Deeksha regardless of their cast, creed, or age.

**Sec. 5. General Provisions**. a. Nothing in this order shall be construed to impair or otherwise affect:

- i. the authority granted by law to an executive department or agency, or the head thereof; or
- ii. The director of the Office of Management and Budget functions relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.
- c. This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
